School's Admissions Preferences – Staff Recommendation

Background

- AB 1505 revised the procedures for making material revisions to charter petitions at the time of renewal. Previously, material revisions could be incorporated directly into the text of the renewal petition. AB 1505 revised the law to require charter schools to submit a separate material revision request to allow authorizing boards to consider the requested changes separately.
- Lodestar submitted a renewal petition on 10/1/20 and an accompanying material revision petition on 10/1/20. The material revision request revises the charter school's admissions preferences to create a priority for homeless/unsheltered students.
- A public hearing was held for the material revision on 11/18/20. Representatives from the lead petitioning group presented.

Discussion

Office of Charter Schools staff and Superintendent recommend approval of this material revision request. We believe this material revision is consistent with the District's efforts to encourage charter schools to serve a higher proportion of high-needs students.

Fiscal Impact Negligible. The overall number of students admitted to the charter

school will not change.

ACTION REQUESTED

Approve the material revision to the Lodestar: A Lighthouse Community Charter School ("Lodestar" or the "Charter School") petition to revise the charter petition's admissions preferences. The text revision (see Material Revision Charter Petition pg. 122-123) amends the admissions preferences to include preferences for homeless/unsheltered students and reduces the percentage of children of Lighthouse staff and Lighthouse Community Public Schools board members in their priority from 5% to 2.5%. Lodestar is requesting this change to the admissions preferences in an attempt to recruit and accommodate unsheltered students. If adopted, these revisions would take effect when the new charter petition takes effect (July 1, 2021) and would continue through the rest of the charter term (June 30, 2023). These revisions do not alter the likelihood of the petitioners' ability to implement a sound educational program and the petitioners appear to be demonstrably likely to successfully implement the program set forth in the petition.

SUMMARY

Staff recommends that the OUSD Board of Education approve the material revision of Lodestar's admissions preferences. Staff recommends approval based on the following:

- 1) There are approximately 1,064 homeless/unsheltered students in OUSD, including OUSD-authorized charter schools, meaning this admissions preference change prioritizes a large group of vulnerable students in Oakland.
- 2) This change to admissions preferences may help diversify student enrollment at the school, and is inline with the District's efforts to encourage charter schools to serve a higher proportion of high-needs students.
- 3) The admissions preference change is compliant with law.

PROCEDURAL BACKGROUND

1) AB 1505 revised the procedures for making material revisions to charter petitions at the time of renewal. Previously, material revisions could be incorporated directly into the text of the renewal

- petition. AB 1505 revised the law to require charter schools to submit a separate material revision request to allow authorizing boards to consider the requested changes separately.
- 2) Lodestar submitted a renewal petition and accompanying material revision petition on 10/1/20.
- 3) A public hearing was held on 11/18/20. Representatives from the lead petitioning group presented.
- 4) A decision hearing is to be held on 12/2/20.

STATUTORY BACKGROUND

Pursuant to Education Code §47607(b):

Renewals and material revisions of charters are governed by the standards and criteria described in Section 47605, and shall include, but not be limited to, a reasonably comprehensive description of any new requirement of charter schools enacted into law after the charter was originally granted or last renewed.

DISCUSSION

Staff conducted an evaluation of the proposed material revision pursuant to the Charter Schools Act. It was determined that the changes made to the admissions preferences were compliant with relevant law and would be of benefit to students and families in the Lodestar school community.

ANALYSIS

When evaluating the strength or weakness of a proposed revision, staff assess the whether the proposed changes are:

- Compliant with relevant law
- Beneficial to students/families
- Reasonably comprehensive and likely to be successfully implemented by petitioner
