#### **Engaging the Community**

In addition to supporting the Oakland Unified School District (OUSD) Arts Learning District

Design Team, OUSD Visual and Performing Arts (VAPA) consultants Aimee Espiritu and Indi

McCasey also co-facilitate the monthly Oakland Unified Arts Partners (OUAP) meeting. OUAP is

a collective of over 18 community-based arts organizations working to strengthen the arts education ecosystem through collaborative partnerships with OUSD public schools. VAPA Director Phil Rydeen regularly attends the meetings to provide district updates on arts learning and will connect community organizations with OUSD Arts Learning District Design Team initiatives. Over the past 2 years, the OUSD VAPA team has updated its webpage and built a social media presence on Instagram to amplify arts learning throughout the district. We will continue to utilize this platform to engage our local community and keep them informed.

#### **Key Components of an Arts Education Program**

1. CONTENT: Curriculum, Pedagogy, Student Assessment, Professional Development.

In order to address all three goals/objectives of this project, the OUSD Arts Learning District

Design Team will focus on the ongoing projects of: 1. identifying a scope and sequence for K-8

VAPA curriculum across disciplines that incorporates New Core Arts Standards, 2. incorporating culturally responsive and anti-racist teaching practices throughout all of VAPA, and 3. continuing to provide professional development around engaging English Language Learners, and 4. cultivating digital resources for distance and hybrid learning options that will offer teachers flexibility when in person learning resumes.

# 2. SUSTAINABILITY: Policy, Funding, Program Evaluation, Communication, Advocacy, District Leadership.

OUSD's *Arts Learning District Design Team* will work to continue to invest Measure G resources into program development through the Arts Incentive Grant (AIG) mini grant program. Currently this program provides key resources for long-term partnerships between community-based arts organizations and 15 Title I OUSD public schools. This proposal will help the team to identify additional strategies that will support arts learning through better utilization of AIG funds, Professional Development opportunities and curriculum development and dissemination.

Additionally, the Arts Learning District Design Team will collaborate with OUAP as they continue to advocate on the city and school district level for increased funding for arts education. Within the next 2 years, the OUSD Arts Learning District Design Team will work to ensure that OUSD's school board adopts the Declaration of the Rights of All Students to Equity in Arts Learning.

## 3. INFRASTRUCTURE: Administration/Coordination, Personnel, Facilities & Equipment, Partnerships & Collaboration (CAAE, 2017).

OUSD currently has a full time VAPA Director as well as a part-time Teacher on Special Assignment to support its Elementary Music Program. This proposal will further strengthen the partnership with consultants Aimee Espiritu and Indi McCasey as well as support stipends for VAPA's Professional Learning Advisory Committee (PLACe), a group of VAPA teachers that represent visual arts, music, dance, and drama programs throughout the district and advise the VAPA team on professional development through monthly district network meetings, twice yearly half to full-day workshops, and current online, bi-weekly ARTS Connect convenings.

#### **Sustainability Plan**

Throughout the district, OUSD employs over 100 VAPA specialist teachers: 40 music, 45 visual arts, and 15 dance & drama teachers. Additionally it provides for the development of arts programs by engaging community partners through its Arts Incentive Grant (AIG) program providing resources to 15 OUSD Title 1 public schools to plan and implement site based, innovative arts programs.

These programs and positions are sustained through Oakland Measure G and Measure G1 funding. Measure G provides funding for the OUSD music program and AIG program. Measure G1 has led to an increase in the number of middle school VAPA teachers over the past 3 years.

At least 30% of schools receiving Measure G1 funding are former AIG recipients indicating that the AIG program provided these schools with initial funding to build an emergent arts program at their site that they were later able to leverage Measure G1 funding to continue or expand.

In addition to funding within the district, the City of Oakland has historically supported arts programming in the district through its Art in the Schools grant. When this funding went into hiatus, OUAP organized to advocate to ensure this hiatus would be limited and has been developing relationships with the Cultural Affairs Department and recently appointed Cultural Affairs Commissioners. Additional funders that support partnerships between community arts organizations and OUSD schools include Arts for Oakland Kids, California Arts Council, Oakland Fund for Children and Youth, Alameda County Arts Commission, Hewlett Foundation, and Philanthropic Ventures, among others.

#### **Support & Technical Assistance**

ACOE can support the work of the OUSD Arts Learning District Design Team by convening the district teams occasionally throughout the funding period to provide opportunities to learn from each other. ACOE could further amplify the work of each district through its own communication channels. In addition, ACOE can conduct a case study through this funding about the impact of systems-level, vertically aligned district arts learning teams. Finally, how will these teams inform and influence the work of the ACOE Core Learning Department around visual and performing arts and its relationship to educational excellence and equity?

Funds from ACOE will support the convening of the District Arts Learning Design Team and expand current VAPA teacher professional learning efforts and opportunities. Aimee Espiritu and Indi McCasey have supported the district for the past three years and Sarah Willner has worked with the district for over a decade. They, along with VAPA Director Phil Rydeen, will plan and facilitate these efforts.

The VAPA teachers involved with PLACe will convene three times per year to support District-wide Professional Development "Buy Back" Days in September and January as well as the monthly 2nd Wednesday Professional Development. Additionally, in June 2021 they will gather along with other members of the District Arts Learning Design Team to begin to draft a cross district scope and sequence aligned with the New Core Arts Standards.
