**Action** Approval of Resolution No. 2021-0034 - Black Lives Matter at School Week of Action

**Background** There is a national movement of teachers, families, administrators, and scholars who have called for a “Black Lives Matter at School Week of Action” – a week to come together to proclaim an annual week of actions, affirmation, and solidarity. For the District, the Week would be intended to highlight, uplift and affirm the rich history and contributions of the Black community—in Oakland, the greater Bay Area, and through the county—and to cultivate in the District’s Black students a sense of pride, self-worth, and self-love. Additionally, the Week would encourage ongoing critical reflection and courageous conversations concerning systemic racism, social injustice, racial and ethnic bias and would help to affirm the right of Black students in Oakland to be treated with respect and dignity within schools and within their community.

**Discussion** The Resolution would proclaim that the Black Lives Matter at School Week of Action would occur annually during the Month of February to coincide with, and augment, Black History Month. The Resolution also encourages and welcomes the participation of District educators and staff as well as Oakland families and students in community-based activities and events related to the Black Lives Matter at School Week of Action.

**WHEREAS**, a national movement of teachers, families, administrators, and scholars have come together to proclaim an annual week of actions, affirmation, and solidarity to be called “Black Lives Matter at School Week of Action”;

**WHEREAS**, the Black Lives Matter at School Week of Action in the District is intended to highlight, uplift and affirm the rich history and contributions of the Black community—in Oakland, the greater Bay Area, and through the county—and to cultivate in the District’s Black students a sense of pride, self-worth, and self-love;

**WHEREAS**, Black Lives Matter at School Week of Action is further intended to encourage ongoing critical reflection and courageous conversations concerning systemic racism, social injustice, racial and ethnic bias

**WHEREAS**, Black Lives Matter at School Week of Action is also intended to affirm the right of Black students in Oakland to be treated with respect and dignity within schools and within their community; and

**WHEREAS**, the Black Lives Matter at School Week of Action may offer a variety of educational opportunities, such as workshops, panel discussions, cultural events, instructional activities, and expressions of unity.

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Education (“Board”) proclaims that the annual Black Lives Matter at School Week of Action shall take place during the Month of February to coincide with, and augment, Black History Month;

**BE IT FURTHER RESOLVED**, the Board welcomes the participation of District educators and staff as well as Oakland families and students in community-based activities and events related to the Black Lives Matter at School Week of Action; and

**BE IT FURTHER RESOLVED**, the Board invites educators across grade levels and content areas to use resources that are inclusive of all of our diverse learners to enrich instruction throughout the whole year, not just one week or one month.
