## **BACKGROUND**

The Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act – Oversight Commission has subsequently reviewed and measured the progress of the implementation of each school's approved 2019-2020 School Year Plans, or reserved entitled monies therefor, and has determined, for a variety of reasons, schools in 2019-2020 School Year did not fully implement Plans and expend 2019-2020 School Year allocated Measure G1 funds. The schools have subsequently submitted revised Plans, approved by the Measure G1 Commission on January 12, 2021. The Commission hereby recommends approval by the Board of Education, and if approved by the Board, will permit the carry-over and use of the 2019-2020 School Year unexpended funds in 2020-2021 School Year according to a school's Amended Plan.
