Ratification by the Board of Education of President of the Board's reappointment of Amy Golden (3rd Term) and Harold Lowe (2<sup>nd</sup> Term ), respectively, to the Measure G Committee, for term ending January 31, 2023.

**BACKGROUND/DISCUSSION**

The duties of the Measure G Committee, as defined by Board Bylaw 9131, is to inform the public concerning the expenditure of parcel tax revenues and to review and report on the proper expenditure of taxpayers' money generated by the 2009 Measure G parcel tax.

The Measure G Committee is composed of seven members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's terms of appointment limited to a maximum of three two-year consecutive terms or the fulfillment of unexpired terms thereof.

Both Amy Golden and Harold Lowe have satisfactorily served their prior terms.

I, pursuant to Board Bylaw 9131, hereby reappoint Golden and Lowe, each, as a member of Measure G Committee, and recommend ratification by Board of reappointment of each for term ending January 31, 2023.
