Ask of the Board

Adoption of Resolution No. 2021-0044 - COVID-19 Testing Condition under AB

86

Background

Assembly Bill No. 86 ("AB 86") was approved by the Legislature and signed by the Governor on or about March 5, 2021. It was designed to support and encourage school districts to offer some level of in-person instruction by providing funding to do so as long as districts met certain conditions. One of those conditions is that a school district must "conduct[] asymptomatic testing for staff and pupils participating in in-person instruction consistent with the state-supported cadences set forth in the COVID-19 industry sector guidance for schools and school-based programs" if that district's county is in the purple tier unless the district either provides "in-person instruction" by March 31, 2021, or the governing board of the district adopts, by March 31, 2021, "a plan to provide inperson instruction and has publicly posted its COVID-19 safety plan on its internet website."

Discussion

The District will meet this condition in two different ways. First, OUSD and the Oakland Education Association ("OEA") have reached a tentative agreement ("TA") for certain OEA members to provide in-person instruction starting March 30, 2021. Additionally, OUSD has publicly posted its COVID-19 safety plan online and the Resolution officially adopts the TA as its "plan" to provide in-person instruction for purposes of AB 86.

Fiscal Impact

None. The Resolution itself only helps the District meet <u>one</u> of the conditions necessary to receive funding under AB 86.

COVID-19 Testing Condition under AB 86

WHEREAS, Assembly Bill No. 86 ("AB 86") was approved by the Legislature and signed by the Governor on or about March 5, 2021;

WHEREAS, AB 86 was designed to support and encourage schools to offer some level of in-person instruction by providing funding to do so;

WHEREAS, AB 86 includes certain conditions that must be met in order for school districts to access such funding;

WHEREAS, one of those conditions is that a school district must "conduct[] asymptomatic testing for staff and pupils participating in in-person instruction consistent with the state-supported cadences set forth in the COVID-19 industry sector guidance for schools and school-based programs" if that district's county is in the purple tier unless the district either provides "in-person instruction" by March 31, 2021, or the governing board of the district adopts, by March 31, 2021, "a plan to provide in-person instruction and has publicly posted its COVID-19 safety plan on its internet website"; and

WHEREAS, AB 86 defines "in-person instruction" as "instruction under the immediate physical supervision and control of a certificated employee of the local educational agency while engaged in educational activities required of the pupil," and such instruction "may include hybrid models offering fewer than five days per week of in-person instruction . . . only if the local educational agency offers in-person instruction to the greatest extent possible pursuant to subdivision (b) of Section 43504".

WHEREAS, the Oakland Unified School District ("OUSD") intends to provide in-person instruction, as defined by AB 86, for grades PK-2 and "prioritized pupil groups," as defined by AB 86, starting March 30, 2021; and

WHEREAS, OUSD has publicly posted its COVID-19 safety plan on its internet website at www.ousd.org/reopening2021; and

WHEREAS, OUSD and the Oakland Education Association ("OEA") have reached a tentative agreement ("TA") for certain OEA members to provide in-person instruction starting March 30, 2021, and for all OEA members to be ready to provide in-person instruction starting April 19, 2021.

NOW, THEREFORE, BE IT RESOLVED, the Board of Education hereby adopts the TA as its "plan" to provide in-person instruction for purposes of AB 86, although the TA is distinct and separate from OUSD's educational program referenced in the TA; and

BE IT FURTHER RESOLVED, that OUSD has met both optional the condition established in AB 86, specifically Section 43521(c)(3)(D)(ii), regarding student and staff testing because (i) OUSD will provide inperson instruction by March 31, 2021 and (ii) OUSD has "publicly posted its COVID-19 safety plan on its internet website" and, by this Resolution, the Board has adopted "a plan to provide in-person instruction."
