Approval by the Board of Education of Post-Committee Amendments to Local Business Policy - 7115 Capital Program/ Construction Related Local, Small Local and Small Local Resident Business Enterprise Program.

**Background** 

The Local Business Policy 7115 names the City of Oakland as the singular agency to certify local businesses. The 2018-2019 Alameda County Grand Jury Report – The Oakland Unified School District's Broken Administrative Culture – Millions Wasted Every Year referenced the District's Local Business Policy in Finding 19-10 and Recommendation 19-11. The impetus for the amendments were the Grand Jury Report.

On April 2, 2021, Facilities Committee approved the Amendment to BP 7115 dated March 26, 2021. Amendments that increase access and equity by local businesses have been targeted. This Amendment names five additional local business certifications to be incorporated BP 7115:

- Port of Oakland
- Alameda County Transportation Commission
- Alameda County Department of General Services
- US Department of Transportation
- California Public Utilities Commission

#### Discussion

This Post-Committee Amendment ("Subsequent Amendment") incorporates all the amendments contained in the Amendment that went to Facilities Committee on April 2, 2021 and adds the following:

- Five additional local business certifications to BP 7115 will be for a term of three years.
- After the three-year time period, District staff and consultants will conduct
  an analysis to assess the benefits of expanding the certification pool and
  bring forward any feedback or identify any impacts.

- The District will increase outreach efforts and provide technical assistance and support services to Small Local Business Enterprises and Small Local Residents Business Enterprises doing or seeking to do business with OUSD.
- During the three-year timeframe, staff and consultants will provide periodic reports to the Facilities Committee detailing outreach efforts, training, and number of Local Business Enterprises, Small Local Business Enterprises, Small Local Resident Business Enterprises that have been awarded contracts with the District.

### **Fiscal Impact**

There is no direct fiscal impact from the Amendment or Subsequent Amendment The larger pool of qualified local businesses may improve procurement in the Capital Program.

Board Member, Dr. Gary Yee proposes the following subsequent amendments to the Proposed Recommendations to the OUSD Local Business Enterprise Policy, dated March 26, 2021, that were presented to and passed by the Facilities Committee on April 2, 2021.

Whereas the District seeks to increase the number of Oakland based firms that are eligible to bid on OUSD projects and be recognized as Local Business Enterprises, Small Local Business Enterprises, and Small Local Resident Business Enterprises;

Whereas the OUSD Local Business Enterprise Policy is more aggressive than most other local agencies as our utilization is a requirement not an aspirational goal;

Whereas this subsequent amendment attempts to address criticisms raised in the 2018-2019 Alameda County Grand Jury Report – The Oakland Unified School District's Broken Administrative Culture – Millions Wasted Every Year. Specifically, Finding 19-10 and Recommendation 19-11 stimulated review of the Local Business Utilization Policy and an examination of the pool of local contractors who can fulfill large school construction projects and the nexus between the LBU and increased project costs; and

Whereas as community members have expressed concern that increasing the pool will negatively impact some small local business that have worked on OUSD projects.

We offer the following subsequent amendments to the recommendations:

- The District accept Oakland based businesses certified with Alameda County, Alameda County
  Transportation Commission, California Public Utilities Commission, Port of Oakland, US Department
  of Transportation-Caltrans as eligible to participate in the OUSD LBE program for a <a href="https://district.nih.gov/">https://district.nih.gov/</a>.
   At the end of this timeframe, District staff and consultants conduct an analysis to assess the
  benefits of expanding the certification pool and bring forward any feedback or impacts.
- The District increase outreach efforts and provide technical assistance and support services to Small Local Business Enterprises and Small Local Residents Business Enterprises doing or seeking to do business with OUSD.

There is a fifty (50) % minimum participation requirement for all formally bid public works construction contracts over \$45,000<sup>1</sup> and formally solicited construction related contracts professional services contracts, including, but not limited to, architects, construction managers, inspectors, testing labs and geotechnical engineers, over \$84,100<sup>2</sup>. All informal construction contracts below \$45,000 and all informal construction related professional services contracts below \$84,100.00 will include outreach to certified local firms such that a minimum of three local certified firms are included in the solicitation.
