Action Requested	Approval by the Board of Education of Resolution 2021-0146 Declaring District Personal Property Obsolete, Surplus and Authorizing Disposition Thereof - Vehicles.
Discussion	Following the December 9, 2020, approval of Resolution 2021-0127- George Floyd District Safety Plan (Phase I) that identified the steps necessary to eliminate the Oakland Schools Police Department by January 1, 2021 or as soon thereafter as legally permissible, the District no longer has the Oakland Schools Police Department ("OSPD"). Some former OSPD vehicles were found to be surplus, obsolete, and of no further use to the District. It is the recommendation of the Superintendent of Schools that such items be declared obsolete, surplus and/or sold, donated to a charitable organization or disposed of in the local public dump upon compliance with the provisions of Education Code Section 17545 and 17546, respectively.
Recommendation	Approval by the Board of Education of Resolution 2021-0146 Declaring District Personal Property Obsolete, Surplus and Authorizing Disposition Thereof - Vehicles.
Fiscal Impact	Disposition of the items listed in Exhibit A will reduce the cost associated with the storage, maintenance, and repair on an item that would otherwise generate a cost to the District.

Declaring District Personal Property Obsolete, Surplus, and Authorizing Disposition Thereof - Vehicles

WHEREAS, on June 24, 2020, the Board of Education passed Resolution No. 1920-0260- George Floyd Resolution to Eliminate the Oakland Schools Police Department, which directed the Superintendent to take the steps necessary to eliminate the Oakland Schools Police Department prior to January 1, 2021 or as soon thereafter as legally permissible and to ensure that the District will eliminate the sworn law enforcement employees of the Oakland School Police Department; and

WHEREAS, on December 9, 2020 the Board of Education passed Resolution 2021-0127- George Floyd District Safety Plan (Phase I) that identified the steps necessary to eliminate the Oakland Schools Police Department by January 1, 2021 or as soon thereafter as legally permissible; and

WHEREAS, the District no longer employs law enforcement; and

WHEREAS, former Oakland Schools Police vehicles were evaluated by other departments for suitability and some were determined by other District departments to be suitable for current District need;

WHEREAS, former Oakland Schools Police vehicles listed in Exhibit "A" are deemed no longer required for school purposes or are unsatisfactory or not suitable for current District needs; and

WHEREAS, the Superintendent recommends that the Board of Education declare said District personal property listed in Exhibit "A" to be obsolete, surplus and for items to be disposed of pursuant to applicable law; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby declares said District personal property listed in attached Exhibit A to no longer be required for school purposes, or should be disposed of for the purpose of replacement, or is unsatisfactory or not suitable for school use of current District needs; and

BE IT FURTHER RESOLVED, that the Board hereby authorizes and directs the Superintendent or designee to dispose of each item of the District's personal property listed in attached Exhibit "A" by sale or auction, donation to charitable organization, or disposition in the local public dump upon compliance with the provisions of Education Code section 17545 and 17546, respectively.
