- Ask of the Board Adoption of Resolution No. 2021-0214 Position Additions #3 Fiscal Year 2020-2021
- **Background** During the course of any fiscal year, the District may alter or adjust its staffing based on operational needs to include: re-organization, reclassifications, compliance requirements, or changes in funding. Historically, the District has not provided the net changes in staffing as they occur during the year. This year, staff has started providing the Board with changes in FTE for approval or ratification and will do so to coincide with the interim reports (December/March/May), the adopted budget (June), and as otherwise necessary to provide clarity when such changes take place.
- **Discussion** The adjustments to FTE on the attached document, Exhibit A, include changes made between April 2021 through May 2021 after the 2020-21 budget was adopted in June 2020. Changes in staffing were deemed necessary and critical by the Superintendent and staff. To the extent that these positions are funded by the General Fund, there is no net impact as any increased costs were offset by reductions in other aspects of the budget.
- **Fiscal Impact** The positions funded by the Unrestricted General fund were funded by reducing/amending existing budgets to support the additional positions. The Restricted General Fund positions were funded by planned, new/increased, or available funding in these resources to support the salaries for these positions which were not all created at the time of budget adoption.
