ADOPTION OF DEVELOPER FEE  
JUSTIFICATION STUDY AND FEES**

**TO ALL INTERESTED PARTIES;**

**PLEASE TAKE NOTICE THAT on Wednesday, June 9, 2021, at 8:00 P.M., or as soon thereafter as the matter may be heard, virtually (Live Streaming via Internet and KDOL-TV Channel 27 (Comcast) and Channel 99 (AT&T)), the Governing Board of the District will hold a Public Hearing to consider the adoption of a Resolution to approve the School Facility Fee Justification Report for Residential, Commercial and Industrial Development Projects, February 2021 ("Study") prepared by School Facility Consultants for the District, and approve an increase in Level One Statutory Fees on development projects within the boundaries of the District for the purpose of funding the construction or reconstruction of school facilities pursuant to Education Code section 17620. This fee will apply to new commercial and industrial construction, to new residential construction, and, to the extent of increases in assessable space, to other residential construction as provided by law**

Any interested Party may make an oral or written presentation at the Public Hearing of not more than three (3) minutes within the up to 30 minutes period allowed for the Public Hearing.
