#### October 2020

- Climate Emergency Action Resolution Approved
- OUSD Sustainability Advisory Council (SAC) Established

#### March 2021


- SAC Kickoff with 46 members (!)
- Youth + Adult EJ Facilitation Team
- Members: students, teachers, parents, non-profit leaders, and community members - More students welcome to join (!)

#### August 2021

- Coordinated 10 Council Meetings to date
- Coordinated with the ACC to enhance student engagement

#### By the End of this School Year

 We will draft and propose a district-wide, anti-racist, holistic, ecological sustainability policy for Board consideration

- ❖ We seek consensus to engage in Free, Prior and Informed Consent of Confederated Villages of Lisjan and have sent a letter to Sogorea Te' Land Trust requesting their input on this council's work.
- ❖ We continuously evaluate who is at the table and who is not. Our intent is to always be mindful and ensure equitable representation on this council.







### Structure and Future Goals

#### **Successes**

- 1. Creating subcommittees
  - a. Youth Committee, Coordinating Committee, Outreach Committee
- 2. Self-organized into focus groups
  - a. Energy, Water, Waste, Transportation, Facilities, Purchasing, Revolving Fund, Schoolyards, Curriculum Enhancement, Food Systems/Nutrition, and Adaptation.

#### **Current Focus**

- 1. Working to establish sustainability "baselines" for all areas of focus.
- 2. Reviewing relevant district policy and considering sustainability policy positions.
- 3. Beginning to work on developing the Interdepartmental Task Force.
- 4. Learning how to adapt to a majority in-person district again.
