The Oakland Unified School District ("OUSD") submits this initial proposal to the Teamsters Locals 853 and 70 ("Teamsters") for a successor collective bargaining agreement ("CBA") between OUSD and Teamsters. OUSD proposes to modify, amend, or terminate sections of the CBA. Additionally, the District intends to negotiate any bargainable impacts or effects arising out of any temporary adjustments to District programs in light of the COVID-19 pandemic<sup>1</sup>. OUSD proposes to modify, amend, or terminate the following sections of the CBA:

- 1. Article 5 Compensation
- 2. Article 6 Hours of Employment
- 3. Article 24 Duration
