APPROVING PARTICIPATION IN THE CLEAN MOBILITY OPTIONS VOUCHER PILOT PROGRAM

WHEREAS, Oakland Unified School District (hereinafter, "the District"), as Lead Applicant, submitted a Mobility Project Voucher Application on October 20, 2020, for the Clean Mobility Options Voucher Pilot Program (hereinafter, "CMO"), attached herewith as Exhibit A;

WHEREAS, the application submitted was for the District's EV Bus On-Demand Pilot, in which the District will be partnering with Zūm Services, Inc. (hereinafter, "Zūm") to utilize electric school buses to serve disadvantaged communities to lower levels of greenhouse gas emissions and provide access to safe, reliable, and sustainable transportation in the area;

WHEREAS, the Oakland Unified School District is eligible to receive funding through CMO, a statewide initiative funded by California Climate Investments, and administered by California Air Resource Board's Program Administrator team to provide funding for zero-emission shared mobility options to underresourced communities in California;

NOW, THEREFORE, BE IT RESOLVED:

- The District shall comply with the requirements of the CMO program, which are set forth in the CMO Implementation Manual, available at https://www.cleanmobilityoptions.org/implementationmanual/.
- 2. The District shall review and, if appropriate, approve the grant agreement committing the CMO voucher funds of \$1,000,000.
- 3. The District shall provide the Community Resource Contributions listed below, committed to the project in the CMO application and as amended by the Program Administrator and the District:
 - Assign a point of contact at the District to address project-related matters in a timely fashion:
 - b. Work with Zūm to secure location(s) and all related permits, consents and approvals necessary to develop, install, operate and maintain the electric vehicle fleet and the related charging infrastructure. Such permits may include street installation permits, electrical permits and permits to operate in the public right-of-way.
 - c. Offer the necessary resources to Zūm to support the outreach and engagement of the District's communities and families to educate them and promote the sustainability and equity goals of the CMO program.

NOW, THEREFORE, BE IT RESOLVED, the Governing Board of the Oakland Unified School District, reiterates CMO program commitment and agrees to comply with CMO program requirements to the CMO Program Administrator Team, as set forth above.
