# Please explain briefly your interest in serving on this Committee, Commission or Board:

As a long-time OUSD parent, Oakland resident, and racial, education and economic justice organizer, I am deeply committed to the children and young people of Oakland, and particularly to historically marginalized and under-served low-income Black and Brown students. I grew up in a low-income neighborhood and community where many of us faced challenges. Our experiences were deeply racialized and gendered. As a high school student, I left home and became an emancipated minor. Many of the young people in my neighborhood were dealing with violence and addiction in our homes. Many of the Back and Brown boys ended up in jail and prison. Adults at school were often unaware of the challenges young people in my neighborhood faced. Over the past 18 years, while living and working in East Oakland, I heard stories and met young people who were pushed out of school and lost their lives as a result. Measure N was designed to interrupt these generational patterns. I have seen what a difference strong implementation of Measure N can make for young people in Oakland. I want to support the leadership of students, families, educators, and community partners to ensure that Measure N is leveraged to continue to transform Oakland's high schools through implementing Linked Learning pathways, closing equity gaps, and creating more racially just, relationship-centered schools. Small learning communities with career-oriented pathways, combined with individualized student supports, create the conditions for students and adults to feel known. This creates conditions for students to learn. I want to support young people in my community prepare for college, career, and community success by joining the Commission and supporting strong implementation of Measure N. I'm also excited about the possibility of joining the Measure N Commission at this critical moment, as reauthorization of the measure is being considered.

I have been a volunteer member of various bodies in Oakland Unified School District, including School Site Councils (SSCs) at Manzanita SEED and Community United Elementary School and the District Budget Advisory Committee (DBAC). I organized teams to support the canvassing and phone banking efforts that led to the passage of Measure N. I have led research meetings with school leaders, teachers, families, students, community partners, and district leaders to ground the measure in best practice. Following the passage of Measure N, I helped to develop and support parent trainings to support understanding of Linked Learning and Measure N, and their involvement with their students' education and site-level implementation.

As a community organizer with Faith in Action East Bay between 2011 and 2020, I supported families, students, educators and community partners in school site multi-stakeholder teams to access and analyze data in order to support student academic success and social emotional well-being. This information informed their participation in governance and processes of continuous improvement in schools across Oakland Unified School District, primarily in the East Oakland flatlands. As a union organizer and trainer at SEIU 1021, I led trainings for union bargaining teams and quality service campaigns with classified workers in Northern California. This involved researching and comparing contract language across jurisdictions, reading public sector budgets, etc. As a union organizer and trainer in the private janitorial industry for over 7 years, I conducted research to support industry-wide organizing in order to raise industry standards and win a master contract covering thousands of janitors and their families.

For many years, I have participated on teams that evaluated the OUSD budget, including as a parent leader and member of my School Site Council at Manzanita SEED and a member of Oakland Unified School District's District Budget Advisory Committee (DBAC). I have worked with school site and district leaders to provide budget trainings for School Site Council teams. Finally, as a staff person at Faith in Action East Bay, I wrote grant proposals and reports that involved developing and managing budgets.

Please describe your experience in developing program policy and administrative recommendations? Please be certain to respond to each element of the question.

As a community organizer with Faith in Action East Bay (formerly OCO), I reviewed past policies, conducted one on ones with families, students, and educators, organized meetings to gather input from diverse stakeholders, and worked with school board members to develop policies in Oakland Unified School District, including Board Policy 3625 in April 2012. In 2013-2014, I supported students and families to advocate for the passage of the Local Control Funding Formula. This included lobbying legislators at the state capitol. Later, I organized with families and students to advocate with the State Board of Education for regulations to enforce the equity provisions in the state law. At the same time, we advocated for and won an equity formula for distribution of funds to schools for site-based decisionmaking at the local level through amending OUSD's Board Policy 3150 in January 2014. Most recently, in my role as the statewide coordinator for the CA Partnership for the Future of Learning, I have supported a partnership made up of grassroots family and student organizations and policy advocacy groups to successfully advocate for a state budget allocation of \$2.8 billion dollars to support creating and expanding transformative racially just, relationship-centered community schools across California. Currently, we are working to ensure that the State Board of Education and California Department of Education develop a CA Community Schools Framework that will ensure that the vision for community schools becomes a reality for low-income BIPOC and other directly impacted low-income students. families, educators, and community partners in schools and communities across California.
