A Listening Session by and between the Charter Matters Committee and OUSD Charter Schools on Security Concerns at OUSD Charter School Sites.

Director Thompson opened the floor for Public Comment, three (3) minutes per speaker per round for a total of 45 minutes of discussion, for the listening session on OUSD Charter School security concerns:

First round of speakers: Dr. Feldman, William Nee, Cesley Frost, Rich Harrison, Maya Woods-Cadiz, Javier Cabra, Jumoke Hinton

Safety concerns and possible remedies raised from the first round of speakers:

- Concerns on inappropriate language and adult behavior around students and how it can be perceived and reenacted by students and the youth.*
- Concerns on safe passage to school for students particularly in respect to houseless person encampments near or within a student's route to school sites.*
- Concerns on fentanyl use and ensuring school sites are equipped with the appropriate remedies such as Narcan for fentanyl overdose.*
- Implementing a unified communication system where Charter Schools are notified of lockdowns or other emergency situations happening within the District in real time.*
- Improved coordination between Charter and District Schools when security issues occur such as updated information on traffic and how to inform parents, emergency personnel and others of route detours to impacted school sites during security breaches and emergencies.*
- Request to convene a meeting with District and Charter School leaders, Oakland City Counsel and the Oakland Police Department to collectively address safety concerns on or near School sites.*
- Conducting safety audits at Charter Schools sites.*
- Consider declaring a state of emergency for the City of Oakland to address violence as a health issue in Oakland.*

- Monthly or Quarterly updates on safety and violence issues for each Oakland City District distributed to schools leaders.*
