#### 15-0570 Conceptual Framework - Application - Education Improvement Plan

Discussion of proposed conceptual framework for an Education Improvement Plan Application.

Staff person, Bernard McCune stated, he and Deputy Chief, David Montez are working on how to incorporate elements that they are looking for in Measure N and Linked Learning into a couple of planning tools that are already used, such as adding a Linked Learning tab in the site planning guide for schools as well as adding graduate profile to the site plan for schools. Mr. McCune also stated, as further orientation to the Board, it will be critical for the Board to see and understand the graduate profile as well as the site planning tools.

#### Follow-up:

*Mr. McCune will be providing a proposed application templet for the Education Improvement Plan.* 

The multiple plans out there right now such as Linked Learning, Connect Ed and others can be consolidated and incorporated into a Single Plan for Student Achievement to a certain extent. A concern is that a Single Plan for Student Achievement (SPSA) format is not going to generate transformative kind of thinking, if it's going to be integrated with the SPSA, given that is the intent of the Measure N.

In the templet to Incorporate inquires about both Piloting and phase in desirable plan and phase in schedules and budgets correlating to those kinds of phase in process, leaving room for failure.

Staff person, Bernard McCune's stated the team would fold some of the things that are needed in Measure N into the site plan, so that it wouldn't be a repetitive plan. Mr. McCune also talked about how to work with schools that might have to go through the intensive school support process to put element that they want to see in a plan for Measure N into that process and not create another plan.
