Foster Youth in OUSD

Who are they? What are their unique needs? How is OUSD supporting those needs? Lydell Willis, Transitional Students & Families; Foster Youth Program

Lydell Willis from Foster Youth showed a video with stories of Oakland foster youth. He gave the group a definition of a Foster Child. He explains that foster children are generally invisible in district planning and that they are spread out across the district. There are over 400 foster children in OUSD, and one person to serve them.

Last year, the LCAP PSAC recommended increasing the number of people to work with foster youth, but the hiring process has been slow, and the new staff has not started yet. He explains that we need a central investment to be sure that schools are meeting the needs of foster children. These are brilliant, resilient kids. We just need to get them the support that they need. LCAP PSAC needs to advocate for these children. Questions to Lydell Willis and responses:

- 1. Do you need more help?
- a. Starting in January I will have 2 case managers. I need 2 more case managers.
- 2. I was a parent leader with AAMA and I was supporting two foster youth. One of them changed homes several times in one year. The school didn't know that he had been moved. What strategies and systems will you use to track this?
- a. This is Child Welfare's responsibility. They need to tell us when a child is moved.
- 3. When we had our D5 LACP PSAC election, they told us that we had to be parents of the subgroups: EL, low-income, etc. So if we didn't have a foster parent in our group, how can we represent you? That is the first problem. According to No Child Left Behind, people had to have a university degree. But a lot of time people with a BA don't understand the needs of the community. What can we do?
- a. The first thing is for you to understand the needs of foster youth so that you can advocate for them. Speak up for them because parents have more power than staff.
- 4. Child Services does the tracking if students move homes?
- a. I can track where they are in the schools. Children's services tracks them in the home.
- 5. What about young people who are not in foster care, but they are on their own?
- a. That is a big population in Oakland. There is someone working with those students under the McKinney-Vento Homeless Assistance Act.
- 6. Where can we find foster parents/students with strategies for how to be successful and how can they speak for themselves?
- a. The best way is through organizations that work with foster families. Also, I am starting an advisory council.
- 7. I am not sure about confidentiality. A friend is a social worker. Are you convening foster families as well as social workers?
- a. One of the biggest issues is that the kids are spread out around the city. I try to find the adult that the child identifies with—a teacher, a coach, a social worker—not necessarily the foster parent. It is different for every child. There are up to 5 people in each child's life.
- 8. Lots of foster kids have been traumatized and often times have to be removed from classrooms because they are acting out.
- a. That mostly happens with my babies—the elementary kids. I want to work with the school to have a plan for that child and welcome that child. Kids are resilient if they can get

a little help. If they are stable at school they usually are stable at home.

- 9. Do they still age out at 18?
- a. No they can stay until they are 24.
- 10. So getting back to OUSD, how can we make sure the school district is doing what the kids need? How can we help?
- a. Just always speak up for them and ask how decisions will impact them. Also, an advocate is going to begin attending these meetings.
- 11. Can we have your phone number?
- a. Yes.
- b. Cintya: I am meeting with Lydell monthly and some of you can join me.
