- Unrestricted General Fund Budget

- Unrestricted General Fund expenses by type - Looking at resources, state loan, infrastructure and school support

- By Object Most costs are in salaries and benefits
- Restricted General Fund Expenditures Most costs are Salaries and Benefits
- School Site Budgets Comparing 2015-2016 and 2016-2017 school year Showing the growth of TK-12 Enrollment
