*For the Budget and Finance Committee to discuss the Postmortem Report and potentially to elevate some things that come out of the report to the Board, said Member Gonzales.*

*What to start the conversation early regarding another cut in the 2018-2019 school year, said Member Gonzales.*

*Hoping to talk about this year is the base staffing allocation, vacancies saving rate, the growth of charter schools, to examine the Central Staffing model comparison with other districts with our size, bidding policies, to lead a study session with the broader Board and how to structure it, said Member Gonzales.*

*School repeatedly stated around increased numbers of English Language Learners and more and more Special Education students to the point where the District didn't follow its own policy when the class size reaches a certain level, there should be additional resources and none was provided. Where it lead to teacher being physically endangered or harmed. So, equity definitely doesn't get felt in many part of this District, said Member Torres.*

- There are some terminology in the policy that was from two Superintendents ago that needs to be updated
- The general public having timely access to accurate, comprehensive, and easily comprehensible OUSD financial management information at the school, department, and district-wide levels
- Any recommendations from Interim Chief Financial Officer on what might be achievable in the short term and a larger projects that might take a little more time with BP 3150

- The next step is for the staff to look at BP 3150 and to come back with comments
- Could adopt as appendix to the Board Policy
- Will work with Superintendent around clarification on the timing for Administrative Regulation

A budget message that articulates our priorities and issues for the upcoming year is the messaging that is lost and the District make things more complicated and hard to understand to follow or to articulate, said Member Torres.

A resolution asking for an implementation memo and a parallel process of moving forward with this set of criteria what the Budget and Finance Committee want to see incorporated into future budget presentations, said Member Gonzales.
