Marion McWilliams, General Counsel, shared:

- Recruitment Cost and Administrative Cost
- Did review the language of the Measure, which is kind a like the guiding light
- Part of the language is to attract and retain highly qualify teachers the verb attract would include recruitment of highly quality teachers, to the extent that the dollars are relating to recruitment effort it's an appropriate expense
- If the Committee have concerns relating to amount or wants to flag for the Board for consideration of the cost in the report
- The Committee can ask for accountability like how are the Measure G dollars going towards recruitment, how successful are those recruitment efforts in obtaining highly qualify teachers
- For the administrative piece, did not see language expressly in the act talking about administrative over head
- There is some administration cost would be reasonable, but its not specifically carved out in the act
- The bench mark would be between the 1% and the 10%

Member, Carpenter asked General Counsel to include if the recruitment team is from in house or from outside of the District.

General Counsel also stated:

- The District does have in house Human Resources or Talent team
- The District have implemented a number of employee recognition programs and steps to honor and recognized staff and staff wellness, which

is driven by the Talent Team

- Maybe some pieces that are resource externally like Professional Development design to attract and retain

Member John Baldo asked, why is there a significant difference in the administrative cost between Measure G1 and Measure N?

The language was develop by variety of stakeholders in those discussions there were demand that as much money as possible go out for the purpose of the parcel tax measure and very little be kept for overhead also the Measure N Commission a number the aspects of that Commission have a richer accountability measure, said General Counsel.
