Revised Policy says that except in extreme circumstances one-time revenue in reserves should not be used to fund on going employee compensation, unless such funds are specifically intended to fund salaries.

Member Jumoke Hinton Hodge wanted to know what does Capital Assets means.

Troy Christmas, Director, Financial Services, said, such examples are vehicles, piece of capital equipment, anything that depreciates over time.

Rebecca LittleJohn, Risk Management Manager, said, anything that is \$5,000 and over is a Capital Asset and have to be recorded.

Presentation to Budget and Finance Committee by Financial Staff regarding the Self-Insurance Fund current state, goals and possible adjustment to reach desired outcomes.

The Committee members wanted to understand the current rate of contribution, the trends that are being observed in the Self-Insurance Fund, to explore other options that the Board may want to consider going forward in terms of replenishment of the Self-Insurance Fund.

Rebecca LittleJohn, Risk Management Manager stated:

- Looked at the last five years, there's a growth in expenditures in Fund 67, about \$2 million a year
- Bringing in monthly around \$2 million in District's premiums based on sur-charge in payroll

Has the Board or District leadership done anything to augment the Self-Insurance Fund so the growing used of it can be respond to? asked, Chairperson Gonzales.

Prior years ago the District did increase the premium to around 5.75%-6.25%, its been lower to 6% this year. Trying to reduced costs, especially with return to work program, but no matter what, the medical costs, continued to grow, said LittleJohn.

The Committee and the staff discussed about:

- Used the Self-Insurance Fund to save off not having a fund balance at the end of last year
- Premium Cost going up
- Examples of property Claims
- Replenishment Self-Insurance fund to 40% level
- Based on the layoff and mid-year adjustment
- Assessment of the contribution rate should be for next year
- Other factors that is contributing to the additional \$2 million a year against fund 67
- Parking at 1000 Broadway Permissible used because it is part of a claim
- Other information that would be helpful for the Board to know moving forward, so the Board can make good decisions on behalf of the school District regarding to the Self Insurance Fund
