**Public Comments** 

Andrea Dawson, Chair of Measures A, B & J Independent Citizens School Facilities Bond Oversight Committee, commented on the project. Dawson said the project list does not show the true costs on some of the projects. Dawson called out the Central Kitchen Project and the Glenview Elementary School Project as examples. She said the current spending plan does not include the costs for facility management, a contingency, and community engagement.

Chairperson London said a recommendation to the Board of a proposed reallocation of Measure J Bond Funds may or may not come from the Committee today.

#### **Public Comments**

Andrea Dawson said close attention should be paid to where funds will be taken from to support the new proposed Measure J Funding Plan. The report shows science programming and playgrounds at school sites will take a major reduction in the new spending plan. She said those reductions are not good for the District's overall instructional program.



#### **Report - Funding Streams - Facilities Department**

A Report to the Facilities Committee by Facilities Staff of funding streams and a recommendation to the Board of Education of its priorities for the 2018-2019 Budget.

Chairperson London talked about the current funding streams for the Facilities Department: Measure B, Measure J, Fund 25 (Developers Fee), Fund 35 (State Matching Fund), Fund 40 (Grants), Rebates from the California Solar Initiative, \$14 million from 2012 Prop 39 Energy Efficiency Projects, Prop 51 (new), and Routine Restricted Maintenance.

London said the Committee may make recommendations to the Board for Routine and Deferred Maintenance funding while the Board is in development of the District's 2018/2019 budget.

Public Comments - Andrea Dawson and Mike Hutchinson

Andrea Dawson commented on State matching funds. Dawson said the application requires a certain percentage of the matching funds be set aside for facility maintenance. The District has received \$7 million in Developer Fees that should have been returned to the Facilities Department for growth of the bond program, but it was used for salaries in 2013/14 and 2014/15.

Mike Hutchinson commented on:

- -Blueprint process
- -Prop 39 offers
- -Reprioritization of Measure J project list
- -Facilities Department vacancies
- -Function of the Facilities Ad Hoc Committee

Chairperson London said the purpose of the Facilities Ad Hoc Committee is to make sure the Marcus Foster Educational Leadership Complex is completed. London reference the Council of the Great City Schools article on Deterioration of Schools. On page 16, she said the article speaks to funds being allocated for maintenance and setting aside funds at the beginning of a project to replace it at the end of its life cycle. This was not done for the Administration Building, there were no funds to replace the building when the building flooded.

The recommendation from the Facilities Committee to the Board is in next year's budget, the District set aside, at minimum, its obligation for routine maintenance and set aside an amount for deferred maintenance.

Director Torres talked about the disparity in the condition of some District schools; teaching underfunded in per pupil spending; and poor children's education in buildings that are falling apart.

Director Senn read into the record, the conclusion of the Council of the Great

City Schools article on page 18.

"School district budgets are rarely funded to provide the recommended operations and maintenance funding needed to adequately care for the district's inventory of facilities. This situation forces facilities managers to triage reactive work orders and preventive maintenance based on less than optimal criteria. Over time, this deficit in funding substantially raises the lifecycle cost of the building".

Director Senn said it is really important to figure out our best practices and what can be done to prioritize them.

- 2. Confirm percentage of routine maintenance required, and best practices of a percentage to be applied to deferred maintenance.



## Report - Prop 39 Energy Efficiency Program - Facilities Department

Cesar Monterrosa made the staff presentation.

Monterrosa said the State received some corporate funding and asked several school districts for their feedback on how these funds could be used to generate savings and increase the workforce through construction. The State would fund the projects based on criteria developed by school districts. The funding application formula that was created made OUSD ineligible to apply. To take advantage of these State funds, the District allocated a portion of Measure J funds to make the formula work, called the "Savings to Investment Ratio". Approximately \$8 million was leveraged across 10 years under Prop 39-E. The District applied ahead of time for years 1 and 2. The money has been spent and projects are complete. Current application for the last three years total \$5.3 to \$6.3 million. There is currently a RFQ for these projects for contractors to complete the projects.

Chairperson London requested an updated report showing the projects at each school site, how much Measure J funds were spent, and the amount of matching funds received by the District.
