- -November Measure G1 Commission reviews carryover proposals

Carryover Funds \$5,000 and Above

The long form will be used requiring community engagement with parent group(s) and staff. Meeting documentation must be submitted with carryover request.

- -School sites can amend their proposal during the school year eliminating the need to carryover funds
