A typo was sited and will be corrected. A. Moody to Jody- Feels that it is horrendous that the participation from Board has not been important. Suggests that Board members come to these meetings. Board members have declined because they feel that is not customary to attend. Serrano suggests that it explicitly state that the 7-11 committee role is only to we can only "strongly recommend" to the Board.

Moody asked that they list the consultants and area of expertise.

Xochitl wants flexibility of lease to fit the demographic of the cities. Suggests that there is a change in the process before it gets to the committee.

Shaeonna suggests that there needs to be a mention of the interested parties in the properties and what they intend to do with them made known. If they see a value in the property, what is it? That helps with decisions also.

Lessosn learned while being apart of this process:

- If there will be vacant properties, allocate budget for maintenance.

- Stewart would like to encourage OUSD not to sale. Open up leases for improvement.

- Quevedo wants to partner with other jurisdictions to maintain properties.

- Before we are sworn in, there needs to be a working session where we can actually get the role of the position.

- Moody noticed the absence of general counsel.

- S. Muhammad felt that the committee should have information that is already available because there are some premeditated questions the public or committee may ask, we should not be learning things as they come. It is clear that there are still things we do not know or understand.
- There needs to be a flow chart.
- Outreach tasks for committee members if and when, need to go to the community first. It should be standard practice that consultants that work in the district to work with community members of the district they live in.
- Any unsolicited proposals for property be made aware to us.
- Emailed proposals should be included in the report.
- Add current school members , add appendices of Grand Jury report.
- N. Session suggested a preamble at a past meeting, Lacsado will reach out to Session about it. The Preamble will give heart to the report.
- J. Robins wants for the committee to also add the positives along the way.

In general, people support the idea of Preamble.

- S. Muhammad- We get the information after having to ask for it. The issue is the timing and any follow up to see do we understand. Members of community gets conflicting information by committee members and staff representatives.
- B. Quevedo- If we are including inclusive language of Board. In respect to the Brown Act, will there be two or smaller groups that review the information? How are we being disseminated the report to give feedback? Mike Hutchinson stated none of the Measure J funds was used for these properties.
