Presentation made by Jon Isom, Managing Partner, Isom Advisors.

Isom talked about bond rating strategy, investor outreach, and Underwriter Request for Proposals. The District plans to issue the remaining series of bonds under the Measure J authorization in May/June 2019 for \$175 Million. The original Measure J Bond was for \$475 Million.

Moody's and Standard & Poors (S&P) Bond Financial Rating System have downgraded the District's rating and will continue evaluating the District closely over the next few months and years. Isom Advisors plans to create a ratings presentation booklet that presents the District in a way that maintains or minimizes the downgrade and looking at purchasing Municipal Bond Insurance on the bonds that may bolster the credit rating of the Bond Series.

The Government Finance Officers Association (GFOA) recommends the use of a Request for Proposal (RFP) process when selecting underwriters to promote fairness, objectivity and transparency. Based on the proposal received, the estimated the reduction in underwriting fees from the RFP process is likely to be in the hundreds of thousands of dollars.

Steve McKetty, Moss Adams, reviewed the audit findings.

Moss Adams performed a Compliance Audit for FY 2017/18 on the Measures B & J Bond Funds validating the expenditures were compliant with the specific items listed in the ballot language. McKetty provided an overview of Audit results and specific outcomes

### Audit Results

- The ballot language addresses projects at the District and school site levels; however, it is unclear if some expenditures are allowable per the Bond language.
- The District could not provide adequate documentation to support staff charge allocations the Bond Program.
- The District was unable to explain a \$19,717.50 discrepancy to the Bond Program when comparing the Labor Distribution Report and the Cost Ledger for FY 2017/18

### Specific Outcomes Included:

- Adherence to design and construction cost budget, schedules and timelines
- Financial reporting and internal controls
- Payment procedures
- Change Orders and claim procedures
- Building and Procurement Procedures
- Conflict of Interest Forms for the entire Facilities Management Team

Brendan Havenar-Daughton asked Facilities Deputy Chief White about the Audit Finding on adherence to construction cost.

White said he does not agree with all the Audit Findings. He spoke to the timeline to complete the audit and staff's capacity to submit documents electronically to auditors (auditor's preferred method). White said he hopes Moss Adams accepts the offer for office space in the Facilities Department and expects next year's audit report to be much cleaner.

## Other areas of concern:

Conflict of Interest Statements not found for some Facilities positions
Excessive charges for services
District construction standards
Documentation retention

Edgar Rakestraw, Executive Assistant to the Board of Education and District Form 700 Filing Officer, spoke to the Conflict of Interest Statement not found for all Facility staff. He said some positions may have not been covered by the Conflict of Interest Policy. Rakestraw said he received no inquiry from Moss Adams regarding District's Conflict of Interest Policy.

Victor Valero asked about change orders and the timeline for informing the Bond Oversight Committee.

McKetty said it's typically after the change order has processed approved, not before.

Vice President London spoke to any change in the scope of the Committee's charge in future bonds would cause longer committee meetings and the need for a Consent Agenda due to the different bonds the Committee would have oversight over.

Chairperson Dawson asked Vice President London to request the Board review the Board Policy regarding the Committee's charge.
