#### Report - Office of Charter Schools - Updates - Charters Matters Committee

A Report to the Charter Matters Committee by Sonali Murarka, Executive Director Charter School Office, or Designee, on the following matters:

- Proposition 39
- New Charter Office Staff Member

Sonali Murarka, Executive, Director Charter School Office (CSO), reported on the following subject matters:

Proposition (Prop) 39: Ten (10) Charter schools applied for space to District schools through the Prop 39 process. CSO has reviewed the enrollment projections provided by each Charter District school. CSO decided to object to five (5) of the ten (10) applications submitted for space at District schools. CSO sent rejection letters to the 5 Charter schools. The Charter schools who received a rejection letter have until January 3, 2022 to respond to the decision, if so desired. February 1, 2022, preliminary offer letters will go out to Charter schools. April 1, 2022, final offer letters will be issued as needed. CSO will bring in lieu of Prop 39 leases to the Board of Education for consideration in January 2022.

New Charter Office Staff Member: Sonali Murarka introduced Pavel Vanegas, Analytic Specialist, to the Charter Matters Committee.

COVID Vaccine Mandates: Updating District Charter schools on OUSD COVID policy and how it effects charter schools. On November 10, 2022, CSO held a meeting with Charter school leaders, facilitated by Sailaja Suresh and a member of OUSD Legal Counsel to answer any pressing questions regarding OUSD COVID policy. CSO posted a Frequently Asked Questions (FAQ) to the CSO website on OUSD COVID policy. The two (2) biggest concerns raised from the Charter schools community are:

- 1. Families who do not have regular access to a physician and therefore can not readily get an exemption form filled out in a timely manner.
- 2. The disproportionate impact disenrollment may have on Black and Brown students who are not compliant with OUSD COVID policy.

Oakland School of the Arts (OSA): Madison Thomas, Policy and Compliance Specialist, provided an update. On September 30, 2021, there was a student lead walkout at OSA in response to a sexual assault and misconduct on campus. Following the walkout, CSO meet with OSA leaders to discuss what steps have been taken in response to this situation. Steps taken are as follows:

- Frequent updates to the school community through email communications, board meetings and family meetings.
- Classes cancelled on the Monday following the student walkout for a staff debrief and planning session.
- Sought out external expertise from community organizations to provide

student support.

- Initiated a full review of related OSA policies and procedures.
- Hired an external investigator to analyze all past and present allegations.

On November 2, 2021, the external investigator found no evidence to substantiate any allegations made. Community members raised concerns in regards to the handling of this situation specifically pertaining to the twelve (12) African American male students accused and OSA not taking the proper steps to absolve these students following the investigators report resulting in the ostracization and lost of educational opportunities for these students. The community wants to ensure the Title 9 rights of these students are protected. CSO has a scheduled meeting with OSA and community leadership on this situation the week of December 13, 2021.
