H. President's Address - 5 Minutes

Prior to newly elected President Gary Yee's address:

Director Aimee Eng, recognized by President Gonzales, and Directors VanCedric Williams, Clifford Thompson, and Vice President Benjamin "Sam" Davis, recognized by President Yee, acknowledged Former President Shanthi Gonzales for her service as President, Board of Education, 2021 Term.

Director Thompson also expressed his appreciation for the relationship he and VP Davis developed over the last year; acknowledged that while members of the Board have individual views he said he learned over the last year that he and his colleagues can work together; and congratulated Yee and Davis on election.

Director Mike Hutchinson, recognized by President Yee, expressed his view that the cultural relationship on the Board over the last year has been "toxic,." citing, among other things, that he received a lot of disrespect, lack of his phone calls being returned by his colleagues, community denial of access, lack of in-person meetings, and viewed Board as dysfunctional. He appealed for personal improvement of relationships between himself and his colleagues in coming year and expressed a hope, under President Yee's leadership, that Yee will move the Board back to some of the more traditional relationships and practices prior to the last five years and make a greater effort to bring the community, which he and his colleagues represent, on board.

Vice President (VP) Benjamin "Sam" Davis, having been recognized by President Yee, in addition to his tribute to former President Gonzales, said that he agreed with Director Hutchinson that school board meetings are not always the highest functioning form of human interaction, not easy to figure out improvements; that people are very passionate about their kids, schools, impossible situations arise where Board members are making decisions and balancing VP Davis, having cited things he learned from President Gonzales, stated he looks forward to continuing to learn under the leadership of President Yee.

President Gary Yee then gave the following address:

"Colleagues:

Thank you for the nomination and votes that led to my election today. Director Hutchinson made a strong case for his candidacy, and he and others have called for more in depth sessions- retreats- to discuss the big bucket items that are within our legislative responsibility. I hope that he will join me and staff in planning out an agenda for those to happen in the future. I look forward to partnering with Vice President Davis in forming the new leadership team for 2022.

I thank Shanthi for her leadership over the past year. She has steered us with a steady hand through narrow straits and rocky shoals, and with the Superintendent and her Leadership team along side of her, we have taken

some detours, because there have been no easy answers, but we have kept our north star in view. I intend to continue much of the direction and momentum of this past year's decisions, knowing that circumstances in implementation will require a revisit, like it did with our vaccine requirement at the end of the year.

Each of us is personally and professionally committed to an effective and efficient and equitable school district that cares for every student under its care, and my goal as the President is to be sure that we clearly articulate to our staff - the Superintendent and our chief governance officer - what our policy direction is. I seek an inclusive leadership style that takes into account the perspectives and individual leadership of each board member, while at the same time moving us to clear and well defined actions that reflect the direction of the majority with each vote.

Equally, my responsibility is to be sure that the Superintendent and her leadership team have the opportunity to give us their best professional judgment as to the ongoing efforts they have taken to implement the policy direction that we have given in the past. Our duty as a board is to ensure public accountability for our policy decisions as well as the Superintendent's implementation of those policies. But accountability to me means continuous improvement, it doesn't mean blame.

We are fortunate to have a locally invested Superintendent who has risen through the ranks, had four years to build her leadership team from the ground up, and in her fifth year, developed a concrete three year Strategic Plan, which we adopted last June, which incorporates Board Resolution 2021-0037 to take all necessary steps to eliminate the Black Student Opportunity Gap. Just as a reminder the strategic plan has four goals or pillars:

- 1) Ensuring Strong Readers by 3rd Grade;
- 2) Supporting Powerful Graduates;
- 3) Creating Joyful Schools; and,
- 4) Growing Diverse and Stable Staff

It's hard to keep focused on these goals when we start the year with COVID still present in a highly contagious variant; we live in a city which has seen 134 homicides in the past year; we have declining enrollment which leads to reduced LCFF funding and excess capacity, and concerns by the County Board Superintendent. We have budget pressures which require clear response to the County; we need to settle our labor negotiations to ensure a diverse, stable, and talented professional staff; and we have staff and students who have lived with and through two years of remote learning, hybrid class structures, quarantines and uncertainty. I thank them for their courage, tenacity, and commitment.

Through it all, we have persisted as a board. We each have spent at least 300 hours together this past year, getting to know each other, feeling each other out, arguing, and disagreeing but learning how to work together. I have seen that each of us brings skills, values, and a political perspective to this

leadership table called the Oakland Board of Education. As President, I accept the responsibility of facilitating communication and policymaking in a predictable and transparent manner, with personal accountability. We have important and difficult policy decisions to make and votes to take this coming year, as we did last year, with no easy answers. I trust that when this year is finished, we can look back on it, knowing that each of us was heard, that each of us was treated with respect and fairness, that different policy perspectives were discussed and debated, and that we can agree together that formal votes express to the community, and to our staff, our current collective investment in the Mission, Vision, and Commitments we make as a District, to the families and residents of Oakland. Thank you for you vote and I look forward to working with you this coming year."
