**Title:** Ratification by the Board of Education of a Professional Services Contract between District and Oakland Schools Foundation, Oakland, CA, for the latter to provide 2,240 hours to provide a Family Resource Center to increase the parent participation rates and involvement in the overall school campus and culture. Specifically, the school will measure parent participation and volunteering, student attendance, and the rates of suspensions and referrals. The expected outcomes are: (a) an increase in parent involvement in school functions and conferences; (b) parent/teacher conferences and home visits (to be measured by parent sign-in sheets at those functions and conferences); (c) a 1% increase in student attendance (as measured by the school's attendance reporting); (d) a 10% decrease in the number of student suspensions and referrals (as measured by the school's tracking logs); (e) improved/positive school culture through institutionalization of events co-created with parents (as measured by parent surveys); and (f) an increase in social capital development through the FRC educating parents and community resources for the period August 27, 2012 through June 30, 2013, in an amount not to exceed \$112,000.00.
