Title: Approval by the Board of Education of Amendment No. 1, Memorandum of Understanding 2021-2022 (MOU) by and between the District and East Bay Asian Youth Center, Oakland, CA, amending the Original Agreement in two separate ways, described in more detail in Exhibit A hereto: (1) it modifies the VENDOR's scope of work for after school services at Franklin Elementary School ("I. Amended Scope of Work - After School Program"), and (2) it adds to the VENDOR's scope of work the provision of summer programming at Franklin Elementary School during Summer 2022 ("II. Amended Scope of Work - Summer Programming Addendum"), in an increased amount of \$60,314.00, increasing the MOU not-to-exceed amount from \$157,937.00 to \$218,251.00, for the period August 1, 2021, through July 31, 2022.
