Adoption by the Board of Education, upon two-thirds vote of members present, or unanimous vote of members present, if less than two thirds present, of this Motion, pursuant to Government Code Section 54954.2(b), finding and declaring it necessary to add to today's posted, published Board Regular Meeting Agenda, after the fact, the Closed Session Item of - Legislative File No. 22-2352 - Threat to Public Services or Facilities, in light of the unexpected and unforeseen shooting, this afternoon, in which several persons were injured, on the King Estates School Campus (housing Rudsdale Continuation School and one or more District authorized Charter Schools of the District) in order for the Board to take immediate action including receiving an immediate briefing on the Incident, assessing the continuing danger to pupils, staff and facilities, if any, and determining additional action, if any, that may be warranted of the District to, immediately and foreseeably, secure pupils, employees, visitors and facilities thereof.
