**WHEREAS**, the Oakland Unified School District (“District”) Board of Education on January 25, 2017, adopted Resolution No. 1617-0119 (Legislative File No. 17-0127, Enactment No. 17-0155) creating the Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act Oversight Commission (“G1 Commission”); and

**WHEREAS**, the Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act – Oversight Commission on March 28, 2023, has subsequently reviewed and measured the progress of the implementation of named schools approved 2022-2023 School Year Plan, and has determined, for a variety of reasons, primarily but not exclusively COVID-19<sup>1</sup>, named schools in 2021-2022 School Year did not fully implement Plans, nor expend 2021-2022 School Year allocated Measure G1 funds, and have subsequently submitted a revised Plan, attached and incorporated herein by reference, approved by the Measure G1 Commission and recommended by the Commission for approval by the Board of Education, as stated herein,

**WHEREAS**, the Measure G1 – Districtwide Teacher Retention and Middle School Improvement Act – Oversight Commission on March 28, 2023 and April 11, 2023, reviewed and approved the 2023-2024 Grant Proposal [Application and Education Spending Plan], for each school named herein and recommended approval of the same, as an Award, by the Board of Education,

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Education hereby accepts and adopts the 2023-2024 Measure G1 Grant Proposals for Named Schools and the 2021 - 2022 Amended Carry-over/Expenditure Proposal for Named Schools, as recommended by the Measure G1 Commission as stated herein:


