# What is a School Facilities Master Plan (FMP)?

- Comprehensive Plan that outlines the **long-term vision, goals, and strategies** for managing and improving the physical infrastructure of a public school district; driven by data.
- Serves as a strategic **roadmap** for guiding the **responsible and equitable management** of public school facilities to support quality education and meet the **evolving needs** of students and communities.
- A school-district's FMP describes a set of building and renovation projects that a district will pursue to support its educational mission.



# OUSD Board Policy 7110 - Facilities Master Plan

*“The Governing Board recognizes the importance of **long-range planning for school facilities** in order to help meet the changing needs of district students and to help ensure that **resources are allocated in an efficient and effective manner**. To that end, the Board directs the Superintendent or designee to develop and maintain a master plan for district facilities. The plan shall describe the district's **anticipated short- and long-term facilities needs** and priorities and shall be **aligned with the district's educational goals**.”*

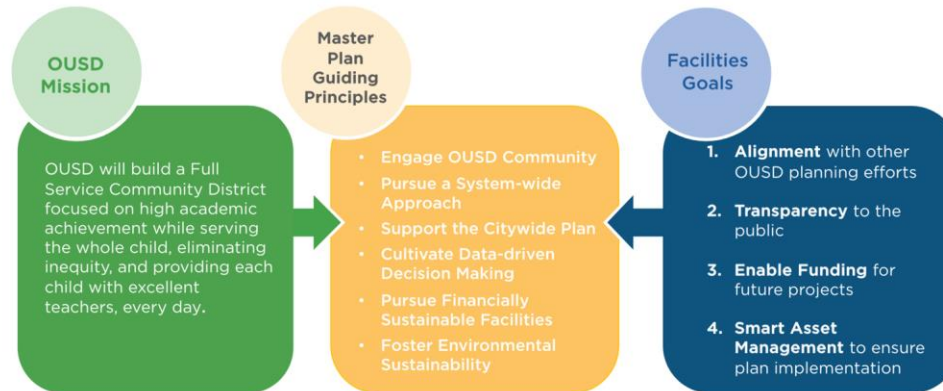


# OUSD Facilities Master Plan, 2020

- 2020 FMP serves as a guiding document for allocating capital improvement funding effectively. Its purpose is to ensure that investments in repair, renovation, improvement, and replacement of District Facilities align with the goals of the Blueprint for Quality Schools initiative and contribute to the development of a Citywide Plan.

The Facilities Master Plan's Guiding Principles are rooted in the OUSD Mission and the OUSD Facilities Department goals.

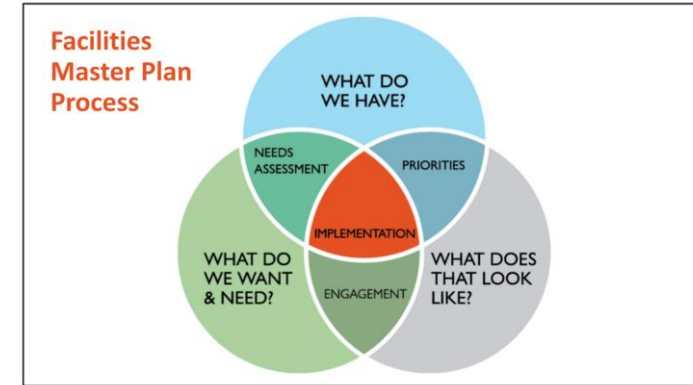
