Hiring Analysis

School Instruction Positions:

- We expect to open school with about 6 ISS vacancies, 34 para-educator vacancies, and 3 teacher vacancies.
- We have 432 para positions, 133 ISS positions, and 383 teachers, which means we have a fill rate of **about 92% for paras, 96% for ISSs, and 99% for teachers.**
- These fill rates are higher than the last three years of tracked data between the Special Education and Talent Departments.

Related Services:

- We are fully staffed for School Psychologists, Occupational and Physical Therapists, APE Teachers, Low Incidence Specialists, and Mental Health Clinicians/Social Workers. We have one SLP vacancy, which is being covered by a virtual provider with an in-person speech technician (**over 99% fill rate**).

Curriculum, Materials, and Instruction

What's New in Curriculum and Instruction

We have developed and prepared to roll out a new Community-Based Instruction training program, which includes providing a budget for CBI activities for Mod-ESN programs in secondary grades;

We purchased a new core curriculum for Mild-Moderate high school programs for math and ELA;

We're launching a new support staff PD plan for paras and ISSs, with intensive orientation for new hires and monthly options for all staff;

We purchased new ViewSonic interactive boards, computers, and printers for all K-12 Mod-ESN programs;

We're providing sensory toolkits for all self-contained classrooms.

What is Child Find?

Child Find refers to the process of locating, identifying, and evaluating children and youth who may be eligible for special education services designed to meet their educational needs at no cost to families.

Children and youth, ages birth to 22, living in the Oakland Unified School District (OUSD), who are suspected of having a disability may be referred for a possible evaluation to determine if they are eligible for special education services. This includes children and youth who are experiencing homelessness, highly mobile, migrant, wards of the state or enrolled in homeschools.

Additionally, children who live outside of OUSD but attend a private school within OUSD's boundaries may also be referred.

Child Find Activities

1. The use of a child find letter to parents/guardians, or responsible party of a child who may need special education services.
2. Inclusion of targeted questions regarding previous Special Education services in enrollment packets.
3. Screening files and enrollment documentation of all children transferring into the district.
4. Providing information to parents that explains the district's special services and who to contact if they suspect their child may have a disability.
5. Utilizing a clear parent and teacher referral system.
6. Providing annual in-service activities to assist all staff in making appropriate referrals and on the Child Find process and obligation.
7. Screening all children entering kindergarten to identify children with suspected disabilities.
8. Publication of a child find notice in the newspaper and on the district website.
9. Poster on display in the main office of each OUSD school which includes whom to contact if there is a student suspected to be eligible under IDEA.
10. Sending Child Find notices to community agencies (i.e. Regional Center, private schools, etc.)

Addressing Concerns and Alternative Dispute Resolution (ADR)

Alternative Dispute Resolution (ADR), is a voluntary process overseen by a mediator used to settle disagreements between schools and families of children with disabilities at no cost to the parent/guardian. All involved must be willing participants who are prepared and open to finding common ground in the effort to move through the conflict. ADR uses specific techniques to promote understanding, open communication, and arrive at satisfying solutions that support and strengthen relationships. ADR is designed to meet the interests of all parties involved which results in a crafted, mutually agreeable outcome, rather than having a decision made by a third party such as a hearing officer or judge.

Common Back-to-School Questions

Q: What do I do if I have a concern about my child's school assignment?

A: Enrollment is managed by the Student Welcome Center. You can contact them through enroll@ousd.org, visiting in person at 746 Grand Ave, or calling or texting 510-879-4600.

Q: My child has transportation in their IEP and I need to sign up for it. What do I do?

A: Please contact the transportation team at transportation@ousd.org if you need support signing up. All of the forms to do so are on the ousd.org/transportation website.

Q: I want to request an IEP meeting to discuss my child's services or progress with their new team. Who should I contact?

A: Please submit a request to your child's school, either with the main office staff or their Special Education teacher. If you can submit it in writing, that is best, but if you cannot, staff must assist you in writing your request.

Q: What do I do if I think my child may have a disability that requires Special Education?

A: Child Find steps depend on your child's age and enrollment. If your child is aged 3-5, contact our diagnostic center team at silvia.nuno@ousd.org or 879-5004. Forms and information are available at burbankprek.org. If your child attends an OUSD K-12 school, submit a request for evaluation to the main office. If your child is an Oakland resident in a private school or at home aged 6-21, contact Peggy.Forbes@ousd.org.

Q: I'd like to visit or volunteer in my child's class, so how do I sign up to do so?

A: The process to volunteer is explained on the Oakland Ed Fund website here: <https://www.oaklandedfund.org/programs/volunteer/>. A background check and negative TB test are required. Note that OUSD Board Policy sets the policy for volunteers. While one-time visits are always welcome, to ensure student focus during instruction, family members may not observe instruction daily/repeatedly.

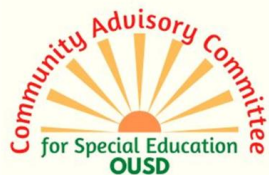
