    - Hire computer science teacher - offer more options to students
    - Stip positions
      - We have 2 staff members there currently, formerly in support staff positions working towards teaching credential

- Plan for 24-25 is to try to keep the stip positions, if not then shift back to Newcomer support positions, and make up the difference based on their work performed
