Subject: Measures N and H Recommendations for 2023–2024 Carryover Funds

Date: Dec 10, 2024

OVERVIEW & OBJECTIVE,

Sixteen OUSD district schools, ten charter schools, and the Measures N and H Administrative 10% have unspent Measures N and H funds from the 2023-2024 fiscal year. Of these twenty-seven sites, seven OUSD district schools, nine charter schools, and the Measures N and H Administrative 10% submitted their 2023-2024 Measures N and H Carryover Plans at the December 10, 2024 Measures N and H Commission meeting. These plans articulate the context that contributed to the carryover, the amount and percentage of Measures N and H funds being carried over, and a clear budget for the carryover funds.

Per Measures N and H Commission policy, approval from the Measures N and H Commission is required for all Carryover Plans. Measures N and H staff have reviewed the submitted 2023-2024 Measures N and H Carryover Plans and provided feedback to the school sites, which was addressed before submission to the Measures N and H Commission.

Teacher Salaries Stipends: Extended Contracts for 25 pathway teachers to have planning time to integrate the pathway theme into their core content curriculum alongside intentional supports to develop student literacy. Specific duties include each teacher meeting with admin or pathway lead to review pathway integration expectations and framework for supporting literacy development and time for development and refinement of curriculum that supports the integration. Planned objectives for this work include strengthening connections between core content and pathway themes, further articulating supports for literacy development across the curriculum, and increasing student engagement as measured by percentage of students who are on track to graduate and/or showing growth in literacy as measured by i-Ready. This expenditure will benefit Pathway students by supporting teachers in building their capacity to engage students more deeply and effectively while also building student literacy to allow them to access the full range of pathway programming. This expenditure aligns with our 3 Year Quality goal of developing a coherent system of structures to support literacy development such that all students can access pathway instruction. Consultant Contracts: Contract with Safe Passages to process and pay-out the Student Internship Stipends for participating in the Work-Based Learning (WBL) Career preparation and training experiences, through June 30, 2025. The students will be able to complete internships by completing client work for school-based and external clients. Students acquire 1) Professional Communication Skills. 2) Career Exploration 3) Community College Orientation and Education Plans. This allocation is not an existing allocation anywhere in our 2024-25 school budget. Student interest is high and we are confident we can spend these funds to support 31 students. Internship stipends have increased the participation of students in our pathways. Budget: 30 stipends at \$599 per student + 10% Agency Admin Fees = \$19,767.00 Safe Passages can only invoice schools for student stipends with 100% participation and completion of the internships, in addition to the admin fees for those funds. Safe Passages can not invoice for the full contract amount prior to the program ending. Consultant Contracts: Contract with the Oakland Public Ed Fund (OPEF) to process and pay-out the Student Internship Stipends for participating in the ECCCO (Exploring College and Career Opportunities) Program, through June 30, 2025. This money will be distributed through the Oakland Public Education Fund and the money will be used to issue student stipends for the summer internships coordinated with ECCCO partnership and each pathway. This funding directly benefits Pathway students by providing them with real world experience directly related to their pathway and increasing their access to industry partners. With these funds we hope to serve approximately 27 students at \$500 each, including indirect costs for OPEF. This expenditure aligns with our Strategic Action of increasing student participation in Work Based Learning experiences by 15%. (Administrative Fees Included) OPEF can only invoice schools for student stipends with 100% participation and completion of the internships, in addition to the admin fees for those funds. OPED can not invoice for the full contract amount prior to the program ending. Professional Contracted Bus Services: Charter bus rentals for pathway students to attend College and Career Exploration Visits (UC/CSU). Funding for transportation costs for students to participate in College and Career Exploration visit field trips. Students will explore academic programs that align with their pathway and the linked learning pillars to support successful post-secondary transitions. These experiences will increase student engagement by providing interactive, real world opportunities that directly relate to pathway development. Funding will be used for transportation for four trips, to include students in both grades 11 and 12. Teacher Salaries Stipends: Extended Contract for 1 Teacher to support the Exploring College, Career, & Community Opportunity Summer Program (ECCCO), through June 30, 2025. The ECCCO teachers will support students in summer internships by providing work based learning curriculum to students, assisting them to find internships and work site visits. This expenditure is aligned to pathway development goals in the area of Work-Based Learning, supporting students to successfully complete career preparation experiences in the district-sponsored summer internships ECCCO program. 20-25 students will be served by this teacher. This addresses the need for a support infrastructure and advocacy for student success in off-site work experiences, as well as logistical needs for making students get paid and prepare for the district Demonstration of Mastery. Bart & Bus Passes: To purchase AC transit bus tickets for pathway centered field trips, summer internships, college and career field trips, and work based learning opportunities for students. These excursions into the field will help our students engage in opportunities to learn outside of the classroom environment. Up to 100 students will be served and gain knowledge and experiences that improve continuous engagement.
