### MEMORANDUM

Re: Young Adult Program and Measure N

---

#### Background

- During the Measures N and H Commission meeting on September 3, 2024, Commissioners requested additional information about the inclusion of the Young Adult Program in the initial Measure N application process conducted in Spring 2015.
- The Commissioners also raised the following questions:
  - Was District leadership aware that the Young Adult Program was a school?
  - Did the Young Adult Program attempt to participate in the Measure N application process, and were they informed of their ineligibility?
- Information gathered up to that point was presented to the Measures N and H Commission and the public at the regularly scheduled Commission meeting on November 5, 2024 (File # 24-2162).

#### Process updates since November 2024:

- High School Superintendent Sifuentes requested access to archived emails and documents related to Measure N from OUSD Tech Services and OUSD Legal. The request covered the following OUSD employees who were involved in the implementation of Measure N between 2014 and 2016:
  - Gretchen Livesey, former Director of Linked Learning (College and Career Pathways)
  - Bernard McCune, former Deputy Chief, Office of Post-Secondary Readiness
  - Joanna Vasquez, former Measure N Coordinator
- The search was conducted using the following keywords:
  - Measure N
  - Special Education
  - SPED
  - Young Adult Program
  - YAP
- Once OUSD Tech Services located the relevant emails and documents, a staff attorney from OUSD Legal reviewed and redacted them as necessary to ensure confidentiality.
- The emails containing the specified keywords were provided to High School Superintendent Sifuentes, with the following results:
  - Gretchen Livesey: 93 emails
  - Bernard McCune: 44 emails

### Findings:

- On May 11, 2015, the OUSD High School Network Superintendent emailed the Measure N planning grant application and other supporting documents to a group of Oakland charter school leaders before sharing them with OUSD high school principals on May 12, 2015.
- An email dated September 25, 2015, from Kevin Schmidke, Data Analyst for OUSD Research, Assessment, and Data, to Bernard McCune and others included a data spreadsheet with student outcome data for all OUSD sites serving students in grades 9-12 (Attachment 1). The data covered the following categories:
  - Enrollment
  - 12th grade cohort graduation data
  - Students with one or more failing grades
  - Grade 10 CAHSEE pass rate
  - Grade 12 CAHSEE pass rate
  - Graduates with A-G
  - Pathway enrollment
- Mr. Schmidke's spreadsheet listed all OUSD high schools, including the Young Adult Program. Data for the Young Adult Program was provided in the following categories:
  - Enrollment (page 24)
  - Student Attrition (pages 53-54)
- There were no emails that discussed the Measure N application and the Young Adult Program.
- The remaining emails containing the keywords "Measure N" and "Special Education" were related to:
  - The number of students enrolled in Resource and Special Day programs at OUSD high schools, as reflected in the Measure N planning grant application document.
  - The need for Linked Learning Pathways to reflect the school's enrollment demographics, including race, ethnicity, Special Education status, and other categories.

### Additional considerations:

- OUSD Legal is still reviewing additional information requested from OUSD Tech Services, including archived emails and documents related to Joanna Vasquez. However, the information has not yet been provided to High School Network Superintendent Sifuentes.
- As clarified by the emails and documents, any relevant information that addresses the questions raised by the Measures N and H Commission will be shared with the Commission and the public at a future meeting.
