Subject Naming the McClymonds High School (HS) Gymnasium in Honor of William F. “Bill” Russell, Alumnus, Civil Rights Activist and NBA Legend.

Action Requested Adoption of Resolution No.2425-0204 - Naming the McClymonds High School Gymnasium In Honor of William F. “Bill” Russell, Alumnus, Civil Rights Activist and NBA Legend.

Background The District has a longstanding tradition of honoring alumni and community members whose lives reflect the district’s core values of excellence, equity, and leadership. William F. “Bill” Russell, a 1952 graduate of McClymonds High School, exemplified these values throughout his extraordinary career as a student-athlete, an eleven-time National Basketball Association (NBA) Champion, and a pioneering African American head coach. Equally notable is Mr. Russell’s legacy as a tireless champion of civil rights, exemplified by his active support for the 1963 March on Washington and his enduring commitment to social justice.

Per Board Policy 7310, the Board may consider naming or dedicating facilities in memory of deceased community members who made significant contributions to society and to the Oakland community. By naming the McClymonds High School gym in William F. “Bill” Russell’s honor, we pay tribute to his unparalleled achievements on the basketball court and his lifelong advocacy for equality, justice, and the uplift of underserved communities. This naming will be an ongoing source of inspiration and pride for current and future students, highlighting the transformative power of determination, integrity, and community engagement.

In compliance with Board Policy BP 7310, "Naming of Facility," the process to rename the McClymonds HS gymnasium has been initiated. McClymonds HS Leadership, in collaboration with the Facilities Planning & Management team, appointed a Citizen Advisory Committee to review name suggestions and make recommendations. This Committee was composed of site staff, community members, and alumni, ensuring a broad representation of the community. To further engage the community, staff conducted outreach to students, staff, families, and the broader

McClymonds HS community through a survey. This survey aimed to gather feedback and support for the renaming, as well as to solicit suggestions for potential signage and murals that would honor the legacy of William F. “Bill” Russell, an alumnus of the school and a legendary figure in both sports and civil rights.

Recommendation

That the Governing Board, upon recommendation of its Facilities Committee, adopt Resolution No. 2425-0204 - Naming the McClymonds High School Gymnasium as the “William F. “Bill” Russell Gymnasium” and direct staff to install appropriate signage and educational materials commemorating Mr. Russell as an Alumnus, Civil Rights Activist and NBA Legend. The Committee amended the original Resolution, at the request of Mrs. Jeannine Russell, widow of Mr. Russell, changing the proposed name from Bill Russell Gymnasium to William F. “Bill” Russell Gymnasium.

Fiscal Impact

Any costs associated with new signage, plaques, or displays will be addressed through philanthropy/community support or non-bond funds as appropriate and will not come from Measure Y Funds dedicated to the McClymonds Site Modernization.
