Overview of the Young Adult Program

- We serve about 140 students with disabilities and learning differences
 - Serve students in Moderate and Moderate to Extensive Support Needs Programs
 - Majority of students have an Intellectual or Developmental Disability
- We believe that all of our students deserve the opportunity to build their knowledge, learn new skills, and engage in continuing education and employment experiences that align to their needs, skills, and interests. We do this through:
 - Prioritizing Employment First Practices and access to work-based learning experiences in settings that are hired competitively and integrated in the community
 - Individualized and integrated courses of study with meaningful daily/ weekly schedules
 - Providing integrated student supports that encourage a historically marginalized and excluded community from engaging in continuing education offerings and opportunities

Pathway Name: Entrepreneurship Reflections on 2024-25 so far

Challenges:

- Aligning with the structure in light of the inherent differences of a program that is directed toward serving students in Mod-ESN programs
 - Best practices for Mod-ESN community are not always the same for non-disabled peers
 - Continue to develop an understanding of the services and offerings that positively impact all subgroups
 - Need to continue to norm best practices and access points for individuals with ID/DD
- Students in YAP benefit from our specialized and individualized WBL, Program of Study, and Integrated Student Supports. YAP team must ensure that all students in the school have access to appropriate offerings that build their readiness skills based on student need and learning profile.
- Mindset shift across YAP team members to incorporate the tenets of Linked Learning in a way that makes sense for the students of YAP.

Pathway Name: Looking Ahead to 25-26

- Development of industry and community partnerships
- Ongoing need to norm expectations and understanding to ensure that Entrepreneurship and Employment First Practices are utilized to support students with ID/DD as they become college, career, and community ready
- Ongoing need to refine best practices within YAP, and ensure compliance with all funding requirements, to best position students to find their success

We will:

- Work with the pathway team to develop our pathway identity inclusive of demonstrations of mastery and transition portfolios for all students
- Develop community and industry partnerships to improve and enhance offerings to students
- Increase interactions for students with industry partners inclusive of mock interviews, job shadows, and workplace demonstrations to further develop their post-secondary readiness and plans

The Reality Facing our Young Learners





- Employment of Individuals with ID/DD has a long way to go:
 - O General population % employed: 61.9%
 - People with ANY disability: 40.7%
 - People with ID/DD: 13.8%
- Workers with a disability were twice as likely to work part time and are more likely to be self-employed than their non-disabled peers
- Adults with disabilities are twice as likely to have inadequate access to transportation compared to those without disabilities
- In the Bay Area, there are about 40 seats (total) for inclusive college programming
