Approval by the Facilities Committee to move to the Board of Education, Resolution No. 2425-0237 - Authorizing Filing of Application(s) for State Allocation Board-Administered Programs for the Oakland Unified School District.

BACKGROUND:

As a condition of participation in the School Facility Program, submittal of a five-year school facilities master plan, or updated five-year school facilities master plan is required. As regulations are being developed, the Office of Public School Construction is requiring an approved resolution acknowledging the five-year school facilities master plan requirement be submitted with applications.

FISCAL IMPACT:

Any application submittals approved by the State through this process will result in reimbursement of funds. Reimbursed funds will be added to the General Fund and Building Fund, and made available for future facility modernization needs.

WHEREAS, the Oakland Unified School District is aware that all application submittals on or after October 31, 2024, are subject to Section 17070.54 of the Education Code;

WHEREAS, the Oakland Unified School District is aware of the minimum requirements for the five-year school facilities master plan as outlined in Section 17070.54 of the Education Code;

NOW, THEREFORE BE IT RESOLVED THAT, as a condition of participating in the SFP, as administered by the SAB, the Oakland Unified School District shall submit to the DGS a five-year school facilities master plan, or updated five-year school facilities master plan, approved by the Governing Board of the Oakland Unified School District for all application submittals on or after October 31, 2024:

BE IT FURTHER RESOLVED THAT, the Oakland Unified School District, as a condition of SFP participation, shall submit the required five-year school facilities master plan within 90 days of the Office of Public School Construction notification of processing the application; and

BE IT FURTHER RESOLVED THAT, the Oakland Unified School District acknowledges that failure to submit

an acceptable five-year school facilities master plan may result in rescission of project funding.
