Subject Amendment of Notice of Layoff: Classified Employees – Reduction in Force Due to Lack of Funds and/or Lack of Work - 2025-2026 Fiscal Year - Talent/Human Resources.

Ask of the Board Adoption by the Board of Education of Resolution No. 2425-0081A Amendment of Notice of Layoff: Classified Employees – Reduction in Force Due to Lack of Funds and/or Lack of Work - Talent/Human Resources - 2025-2026 Fiscal Year. which provides for the reduction in force, reinstatement, increase, or creation of authorized classified positions based on lack of funds and/or lack of work as reflected through the budget development process for the 2025-26 fiscal year.

Background On February 26, 2025, the Board approved the reduction of certain classified positions due to a lack of funds and/or lack of work (Legislative File Number 25-0480). The Board is now requested to approve the amended Resolution, which outlines the reduction, reinstatement, increase, or creation of additional authorized classified positions based on the lack of funds and/or lack of work identified through the Budget Development process.

Discussion The Education Code mandates Board action to implement the reduction or elimination of classified positions due to a lack of funds or work. During the budget development process, sites and departments have identified the need to reduce certain authorized classified positions based on budget decreases, site/department reductions, and alignment of work with district priorities.

Under state law, specifically Education Code sections 45114, 45115, 45117, 45298, and 45308, school districts must notify classified employees of reductions or layoffs. Additionally, Education Code section 8366 allows

school districts to notify child development permit teachers of layoffs at any time during the school year.

The recently enacted AB438 amends Sections 45117 and 88017 of the Education Code and Sections 11503 and 11505 of the Government Code, affecting the layoff timeline for classified school employees. AB438 aligns the layoff notification timeline for classified staff with that of certificated staff, requiring notices by March 15th or in May for categorically funded positions. These notices include the effective date, displacement rights (if any), and reemployment rights. Although employees affected by position reductions or eliminations will receive layoff notices, some may retain District employment through reassignment as permitted by the Education Code.

Exhibit B lists the positions that will be reduced, eliminated, or added. The total effect of this resolution is to increase the overall number of authorized classified positions.

Fiscal Impact

Budget changes needed to assist in addressing the District's declining enrollment, the elimination of certain funds, the District's fiscal health, and staffing needs. For the 2025-2026 fiscal year, there will be savings of salary and benefits for positions no longer funded.

Exhibit B: Classified Layoff Amendment - 2025-2026 Fiscal Year

WHEREAS, the District, impacted by the anticipated loss of revenue from the federal government and facing increased costs, must reduce its expenses in Fiscal Year 2025-2026 and ensure that expenditures are aligned with the District's Strategic Plan and budget priorities; and

WHEREAS, the primary mission of the District is to educate its early childhood, K-12 pupils with the annual resources, revenues at its disposal; and

WHEREAS, for Fiscal Year 2025-2026, based on an anticipated lack of funds and shifts in work to increase efficiencies, it is necessary for the District to streamline, reorganize, reduce and/or eliminate positions, in whole or in part; and

WHEREAS, Education Code Sections 45101, 45114, 45117, 45298 and 45308 require action by the Board of Education if services for classified and certificated staff are in good faith to be reduced or eliminated in order to permit the layoff of classified employees due to lack of funds, lack of work and/or program need, and

WHEREAS, The Board, on February 26, 2025 (Legislative File Number 25-0481) approved the reduction or layoff of certain classified and certificated positions based on lack of funds and/or lack of work.

NOW, THEREFORE, BE IT RESOLVED the Board of Education ("Board") hereby determines that the following classified positions, detailed in Exhibit B: Classified Layoff Amendment 06.25.25 (attached and incorporated herein by reference), shall be and hereby are eliminated or reduced due to lack of funds and/or lack of work or restored due to the restoration of grant funds or program change within allocated budget; and

BE IT FURTHER RESOLVED, that the Board of Education authorizes the Superintendent of Schools or her designee to: (1) send appropriate notices to all classified employees whose positions are lost, reduced, or otherwise impacted by the foregoing elimination and/or addition of positions; and (2) to take all proper steps pursuant to Education Code Sections 45117 and 45308 to effectuate the Resolution; and

BE IT FURTHER RESOLVED, the Board, in approving this Resolution, intends that the position results labeled in the column "FTE (25-26)" be achieved.
