Background &

Discussion

The District entered into a Contract with Fred Finch and Family Services on or about July 16, 2023. The Contract's term is July 16, 2023 to June 30, 2026. Section 11.a of the Contract permits OUSD to terminate the Contract, for convenience, with 30 days' notice to the vendor, which staff has given.

Staff wish to terminate the Contract for convenience due to students transitioning to new clinicians provided by the Oakland Unified School District.

Fiscal Impact

The terminated Contract is for \$1,093,301.00, and \$762,013.00 has already been expended, meaning that \$331,228.00 will remain in the Special Education funding.
