GRANT AGREEMENT BETWEEN NATIONAL PARK FOUNDATION AND OAKLAND UNIFIED SCHOOL DISTRICT AND POINT REYES NATIONAL SEASHORE

GRANT AGREEMENT

1. Project Overview

The National Park Foundation (NPF) is making a grant of \$60,000.00 to Oakland Unified School District in support of "2025-26 Field Science Education Program at Point Reyes National Seashore" program or project:

The 2025–26 Field Science Education Program at Point Reyes National Seashore will connect approximately 350 middle and high school students from Title I schools in Oakland to the ecological and cultural landscapes of Point Reyes through a hybrid engagement model that spans both traditional school-day hours and out-of-school time. Led by Oakland Goes Outdoors, a program embedded in Oakland Unified School District (OUSD), in partnership with OUSD schools and additional program provider partners, the program serves students in grades 6-12 and will include 8-10 trips ranging from day visits to multi-night camping and backpacking experiences between August 2025 and May 2026. All experiences take place at Point Reyes and are designed to build environmental literacy, scientific inquiry, and social-emotional growth through immersive, hands-on learning. Students will engage in ecological investigations, teambuilding activities, and stewardship practices that support NGSS-aligned content in both life and physical sciences while deepening their sense of connection to public lands. Educators are supported through curriculum tools and coordination to integrate and extend the learning experience. By centering inquiry-based learning and emotional development in a national park setting, the program fosters lasting, transformative connections between students, their communities, and nature.

2. Grant Award

Oakland Unified School District will receive a total of \$60,000.00 for the project "2025-26 Field Science Education Program at Point Reyes National Seashore with Oakland Goes Outdoors" (Grant ID: R-202507-18498) and will receive the grant payment after the signed agreement has been returned to NPF.

3. Program Requirements

Following are the basic program requirements:

- 1. Implement the program as outlined in Attachment A, Scope of Work.
- 2. Provide NPF with NPS program or project lead contacts for each program or project.
- 3. Submit timely and complete reports.



4. Include recognition of support by the National Park Foundation and donor (if applicable) in all applicable press releases, articles and related materials, consistent with all applicable laws, policies, and limitations of NPS.

4. Reporting & Evaluation

Oakland Unified School District and Point Reyes National Seashore are to provide the National Park Foundation with reports based on the following schedule:

An annual report to be submitted to the National Park Foundation on or before June 30, 2026 and annually after until the funds are depleted.

If report(s) are not received in a timely manner, the potential of future grants requested from NPF will be impacted. If an extension is needed, send a request to the NPF grants and programs staff member who is the contact for this grant.

A copy of all materials (pictures, video, fliers, posters, hats, t-shirts) produced as a result of this grant must be sent to the National Park Foundation with the final report. Please note, the National Park Foundation will likely request photos, quotes or anecdotes, each year throughout the program/project cycle in order to promote the program, gain media attention, and/or populate our website with programmatic content.

5. Communications

ATTACHMENT A: SCOPE OF WORK

Project Summary

Oakland Goes Outdoors (OGO) proposes to lead a field science program in partnership with Point Reyes National Seashore, providing immersive, sustained learning opportunities for Oakland middle and high school students. The program will engage approximately 350 students across 8-10 planned field science experiences between August 2025 and May 2026. Participants represent primarily Title I schools in some of the most economically disadvantaged neighborhoods in East and West Oakland. Over 85% of students at participating schools qualify for free or reduced-price meals, and approximately 90% identify as BIPOC, including 61% Latinx, 17% African American, and 9% Asian American.

OGO was founded in 2018 through a partnership between the Oakland Unified School District (OUSD), Bay Area Wilderness Training (BAWT), and the Oakland Public Education Fund, with a mission to create equitable access to outdoor experiences for all students regardless of zip code or income level. Originally launched in every OUSD middle school, the program has expanded to serve TK–12th grade, with a particular focus on middle school grades.

Students will participate in overnight and extended-day field trips to Point Reyes that emphasize ecological investigation, community science, stewardship, and reflection. Activities include hiking, nature journaling, team building, community cooking, and ecological monitoring. Lessons are designed to support 6th–8th grade standards in earth science, geology, ecosystems, and weather systems, as well as physical science concepts such as energy transfer, forces in nature, and wave erosion observed along the coastline; 9th–12th grade trips integrate leadership, self-awareness, and environmental literacy. The majority of the overnight trips will be hosted at the Clem Miller Environmental Education Center in partnership with the Point Reyes National Seashore Association (PRNSA).

We have strong, established relationships with staff at both the NPS office and PRNSA, which we are excited to build upon with this grant. We will have at least 5 returning schools taking trips this next year, as well as 2 schools who will be visiting Point Reyes for the first time.

OGO's program model integrates outdoor experiences directly into the public school structure, allowing for more equitable access than standalone after-school or extracurricular programs. We coordinate closely with teachers and school staff to ensure alignment with academic standards and trip readiness, while also reducing the administrative burden on educators.

Educator engagement is embedded through curriculum support, collaborative planning, and post-trip integration of learning. Trips are led by OUSD educators who reflect the communities they serve, building trust and belonging. These experiences have been shown to increase students' confidence, academic interest, and mental well-being. In fact, one school's survey data showed that 97% of students reported that field trips improved their mental health.

This proposal prioritizes continued exposure to public lands throughout a student's academic journey, fostering sustained engagement with these parks and places from middle school through high school. OGO's model supports scaffolded learning, allowing students to deepen their relationship with nature, their peers, and their own development, not only within a single school year, but across multiple grade levels. Many of our partner schools intentionally build on students' prior experiences year over year. At one high school, for example, 9th graders begin their high school journey with a community-building camping trip at Point Reyes and return as 12th graders for a capstone experience, where they read letters they wrote to themselves as freshmen. These multi-year touchpoints encourage long-term reflection and growth, helping students track their personal development and reinforce a lasting sense of belonging in natural spaces. We aim to make this kind of sustained, emotionally resonant outdoor education model both replicable and sustainable across the entire district.

Our aim is for students to build comfort in and connection to the outdoors, encouraging independent and family-based exploration beyond school-sponsored programs. By nurturing a culture of stewardship and curiosity, we hope to support the now and next generations of park enthusiasts, environmental leaders and outdoor recreation advocates.

Project Timeline

Our program follows the academic school year. Planning for each school year begins in early spring of the previous year, with school sites communicating with OGO staff a list of their desired trips. Therefore we already have a good sense of what interest there is from school sites to incorporate programming at Point Reyes this upcoming academic year (August 2025 - May 2026). OGO staff has already begun reviewing these requests, and assisting with the coordination and implementation of trip logistics with input and support from each school site's trip leaders.

In August 2025, when the OUSD school year begins, OGO staff will meet with all school site leaders to confirm programming and trip logistics.

From late August to May, OGO staff will support and facilitate multiple trips for each school site. We expect 3-4 trips to happen during the fall semester (August-November 2025), and

5-6 over the spring semester (January-May 2026).

July 15 – August 15. 2025 (Preparation Phase):

- OGO staff reviews trip requests and confirms participation with prioritized schools
- OGO staff & OUSD teachers collaborate with Point Reyes NS and PRNSA staff to secure site reservations
- When school begins, OGO staff finalize logistics with school site leaders
- OGO staff work with OUSD transportation staff to secure transportation for trips

August 15, 2025 – May 30, 2026 (Implementation Phase):

- OUSD teachers facilitate 8-10 trips to Point Reyes National Seashore for \sim 350 students and 40+ adult leaders
- Trip leaders capture trip documentation (photos, videos, student artifacts) and conduct educator/student evaluations
- OGO staff distribute post-trip surveys and conduct year-end evaluation analysis

June 1 – June 15, 2026 (Evaluation Phase)

- OGO staff evaluate survey responses, confirm attendance, and complete grant reporting requirements
