Action Requested and Recommendation

Adoption by the Measures N and H Commission of a 2025-2026 Education Improvement Plan/Budget modification for Oakland Technical High School to reduce \$91,645.74 Materials and Supplies by \$81,225.00 to \$10,420.74, and establish a new strategic action \$81,225.00 Teacher Salary Stipend, as stated in the justification section of the New or Revised Strategic Action Section of the Budget Modification Form.

Oakland Technical High School would like to reduce \$91,645.74 Materials and Supplies by \$81,225.00 to \$10,420.74, and establish a new strategic action \$81,225.00 Teacher Salary Extended Contract for the Pathway Teachers to provide curricular and structural support schoolwide through collaboration. Budget Compensation: 2 hours per month x 9 months = 18 hours total at \$47.50 per hour + 25% benefit costs = \$1,068.75 x 76 teachers =\$81,225.00.

Additional Duties: The additional duties will happen in pathway meetings, where pathway leads and/or CTE Coaches will provide PD, and where the teachers in the team will collaborate with each other on shared instructional practices, pathway-aligned projects, and student supports using a shared protocol. The pathway teachers will provide professional development and teacher support to continue building out the pathway model and ensure alignment of all classes with the school's mission and vision. Increasing scholar retention and reducing dropout rates by collaborating with case managers to identify and support at-risk and underserved students will allow a greater number of students to be engaged. Learning/Achievement gaps still exist between our focal students and the general student body, and the number of students who are at risk remains. Additional meetings with case managers are required.
