This year, we have utilized our 25-26 grant to fund a Restorative Justice Facilitator position. This position is part of the SEIU union, which is currently engaged in contract negotiations so Fiscal is requiring a certain amount of reserved budget to pay for potential salary increases in the near future. To supplement our safe and positive school culture strategies, we would like to utilize carryover funds to fund our Bilingual Family Liaison position that plays a role on our school attendance team, case managing chronically absent students and increasing family engagement. Additionally, we would like to provide a college campus tour overnight trip for all of our 8th graders to support their future academic goal setting and planning for college and career and reward our students on Honor Roll with a special UPA sweatshirt. Lastly, we would like to provide students with a field trip incentive to reward students that are embodying our core values of respect, leadership and solidarity.

<p>Families agreed with the suggested use of the Measure G1 carryover to pay for a 0.1 FTE portion of the guitar teacher position, for part-time family champion positions, art/music supplies, a reading incentive fieldtrip, and an 8th grade College Tour Fieldtrip.</p>	
<p>One family asked if there is enough money to pay for all of these things and the principal responded yes.</p>	
<p>One family asked if we could use some of this money for food for SSC and the principal responded she would need to check with the G1 Commission to see if that is allowable.</p>	
<p>One family recommended using some money to beautify the bathrooms.</p> <p>The principal explained that the next steps in the process are to submit a plan to the Measure G1 Commission and they have to approve it.</p>	
<p>X. 24-25 CCSPP Carryover - \$21,840</p> <p>The principal suggested that this money be utilized to extend the contracts of our three part-time family champions. Family Champions are UPA family members who work daily on campus to supervise hallways, learn leadership skills, and to encourage more families to engage in SSC, Coffee with the Principal and use their voice to participate in stakeholder decision-making at the school.</p>	Mesa, T. - Principal
