Subject Services For: Castlemont High School

Action Requested and Recommendation

Adoption by the Board of Education, upon recommendation by the Measures N and H Commission of a 2025-2026 Education Improvement Plan/Budget modification for Castlemont High School to the following line items: (1) reduce \$9,950.00 Classified Support Salaries: Hire a Work-Based Learning Liaison at 1.0 FTE by \$9,950.00 to \$0.00, and (2) reduce \$17,000.00 Classified Support Salaries: Hire a College & Career Readiness Specialist at .70 FTE by \$7,300.00 to \$9,700.00, and establish a new strategic action \$17,250.00 Consultant Contract with Oakland Kids First (OKF) to serve as the fiscal sponsor and pay out the Student Stipends for the 2026 Summer ECCCO Program, as stated in the justification section of the New or Revised Strategic Action Section of the Budget Modification Form.

Background

Castlemont High School would like to modify the following line items: (1) reduce \$9,950.00 Classified Support Salaries: Hire a Work-Based Learning Liaison at 1.0 FTE by \$9,950.00 to \$0.00, and (2) reduce \$17,000.00 Classified Support Salaries: Hire a College & Career Readiness Specialist at .70 FTE by \$7,300.00 to \$9,700.00, and establish a new strategic action \$17,250.00 Consultant Contract with Oakland Kids First (OKF) to serve as the fiscal sponsor and pay out the Student Stipends for the 2026 Summer ECCCO Program for Castlemont students participating in summer internships, through June 30, 2026. Budget: approximately 15 additional students with a \$1,000 stipend. (Admin Fees Included - 15%)

Whole School Tab	N/A	N/A	Consultant Contracts: Contract with Oakland Kids First (OKF) to serve as the fiscal sponsor and pay out the Student Stipends for the 2026 Summer ECCCO Program for Castlemont students participating in summer internships, through June 30, 2026. This funding will be distributed through Oakland Kids First and used to issue student stipends for the 2026 summer internships coordinated with the ECCCO partnership and each pathway. Providing students with real-world experience directly related to their pathway-focused academics supports pathway development. Prioritizing students' need for stipends for their work and expanding their access to industry partners and work-based learning opportunities is an intentional choice to enhance student engagement. This is a strong need for our students so they can better connect their in-class learning to their lives and future. Budget: We aim to serve approximately 15 additional students and provide each student with a \$1,000 stipend. (Admin Fees Included - 15%) <i>This allocation will increase the total contract amount, which is already partially funded using 24-25 Measure H Carryover funds (line 15).</i>	\$17,250.00
