Special Education Update: Extended School Year and other Summer Programs

2026 Extended School Year (ESY)

Extended School Year 2026

Extended School Year (ESY) services are primarily designed for students with moderate to extensive support needs. These students may experience significant regression in their skills over a long school break and struggle to regain them once classes resume.

Generally, ESY is not intended for students in resource or mild/moderate programs because these students often benefit more from general education summer intervention programs that allow them to continue their learning with general education peers.

ESY Enrollment

- Enrollment is through EnrollWise.
- You will receive a text or email based on your chosen preference.
- Enrollment begins March 25th and occurs on a rolling basis.
- Speech-only students will not receive an invitation. They will be contacted directly by a Speech Therapist (SLP).
- You may only enroll in 1 district program. ESY is by invitation only, gen ed programs such as Springboard or EL program have open applications. If you prefer the Gen Ed program, contact your school immediately.
- Summer counseling can be offered for those who are in the General Education credit recovery program.

ESY Transportation

If you have transportation in your IEP, there will be a deadline to complete enrollment to get transportation.

This date is not yet available.

How do you apply for transportation?

There is a checkbox on the ESY application.

Other OUSD Summer Programs

Summer Learning District Programs

Enrichment programs are available at ESY locations after the ESY hours end. TK-8 Families will receive an invitation via Email and Text, and will complete registration using our Enrollwise tool.

High School students needing to recover credit will work with their school counselor who will recommend them for summer school if needed.

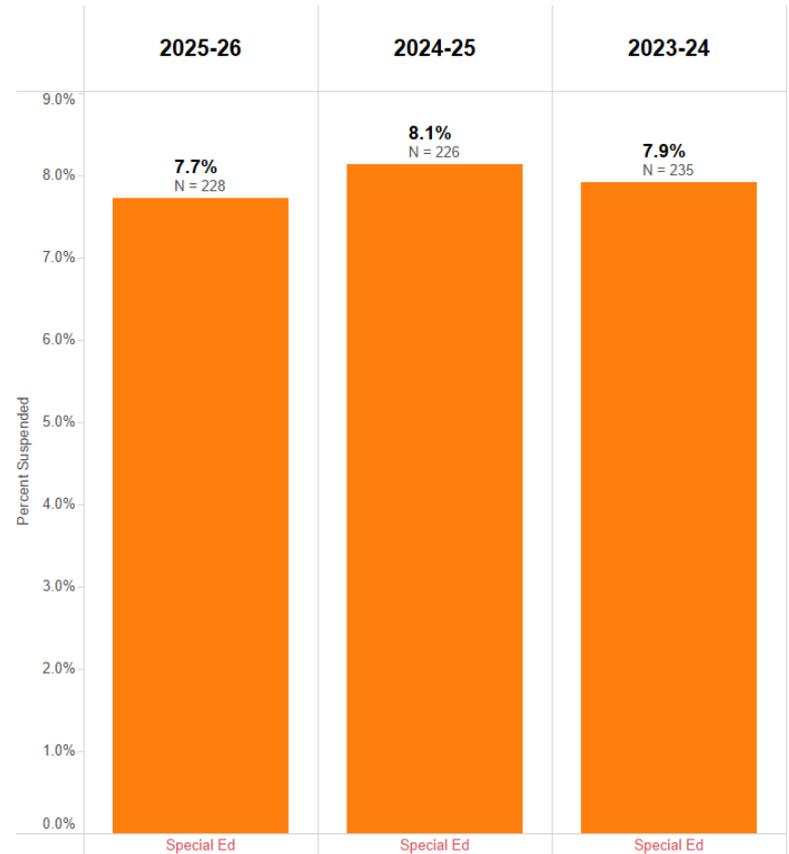

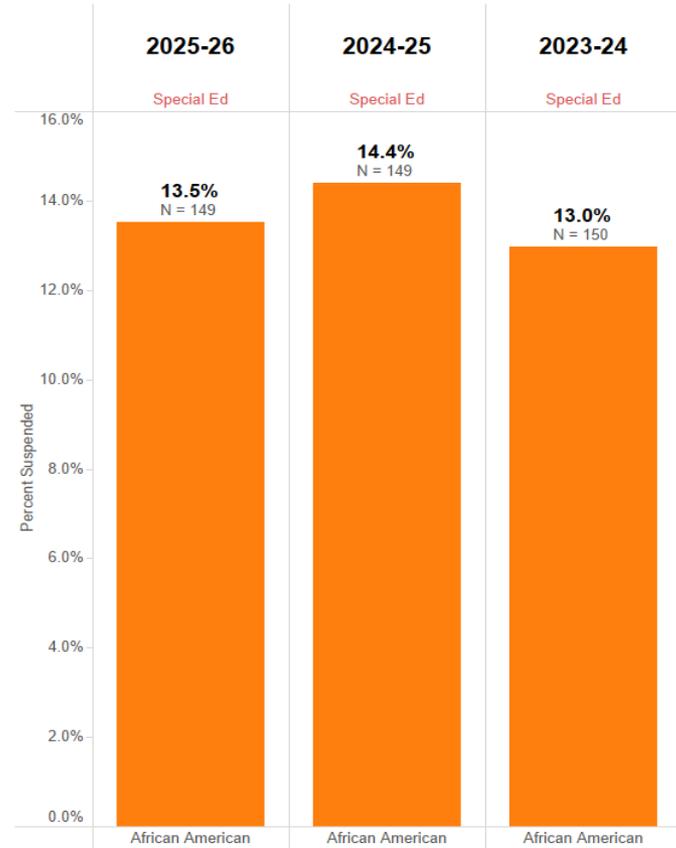
High-Level Suspension Data

Compared to this time last year, suspensions rates for all **Students with IEPs has slightly dropped.**



This chart shows this years current suspension rates as of February 25, 2026, and compares it to this time last year (February 25, 2025) and the year prior (February 25, 2024).


Compared to this time last year, suspensions rates for African American Students with IEPs dropped by nearly 1 percentage point.

Being African American **or** having a Disability significantly increases your likelihood of being suspended


By Race (African American)



The **Year-to-Date suspension rate** for all **African American Students** decreased by 1% compared to last year.

The **Year-to-Date suspension rate** for all **Disabled Students with IEPs** has decreased by .4% in the same time period.

By Special Education Status

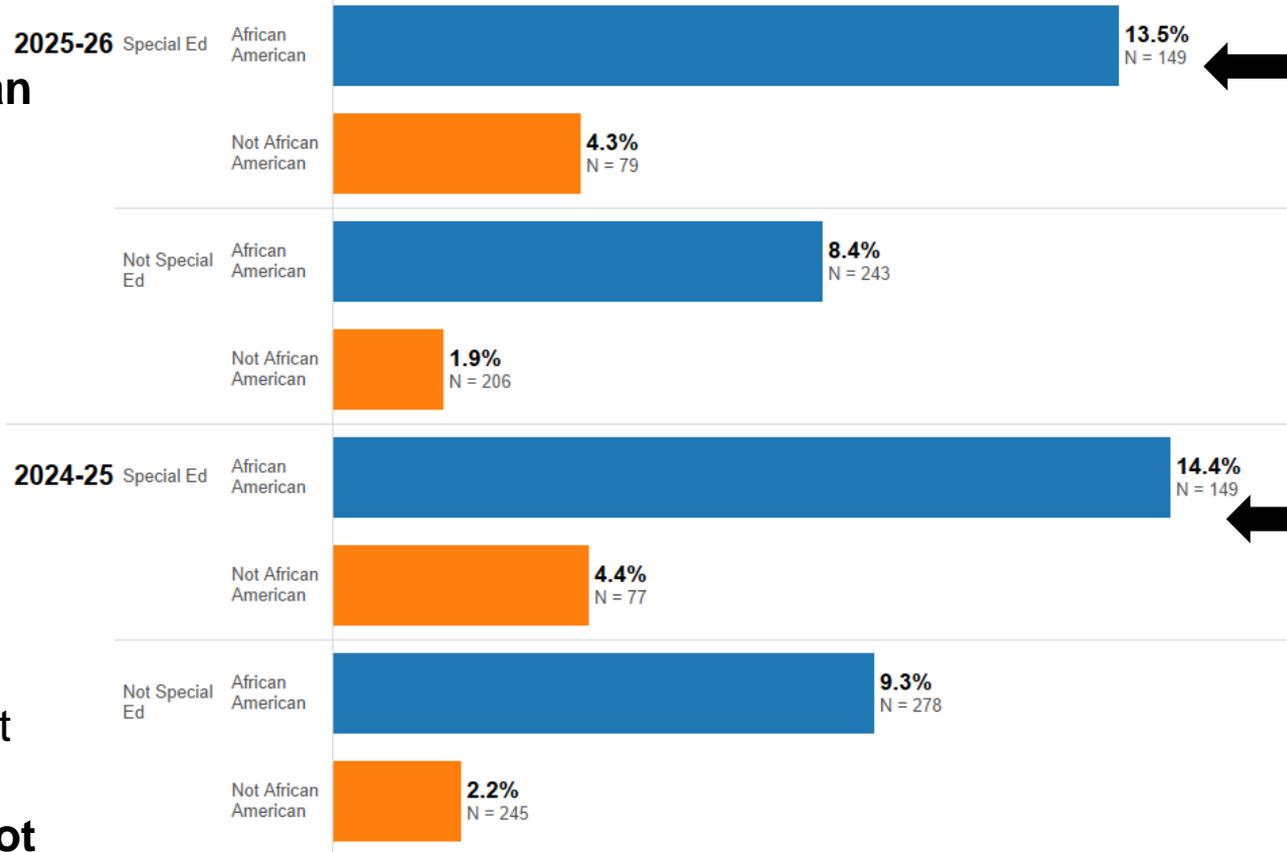


Overlapping Student Demographic Data

The Year-to-Date suspension rate for African American Students with IEPs decreased by 1.1 percentage points compared to this time last year.

Their suspension rates remain higher by 4 percentage points than their non-disabled African American peers.

They are also suspended at 3 times the rate of their disabled peers who are not African-American.

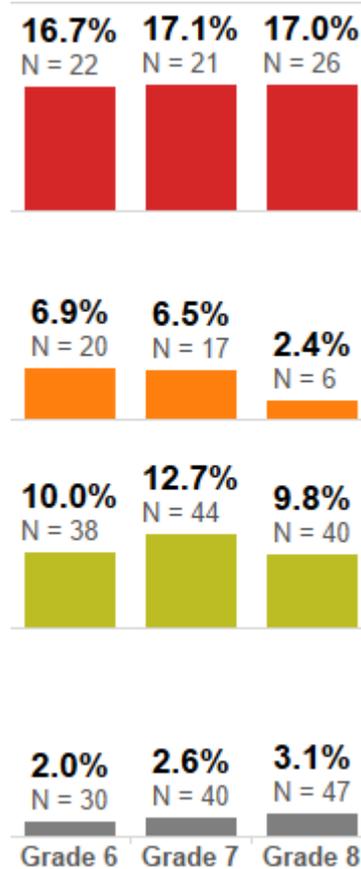
Breakdown of Suspension rates for students who are

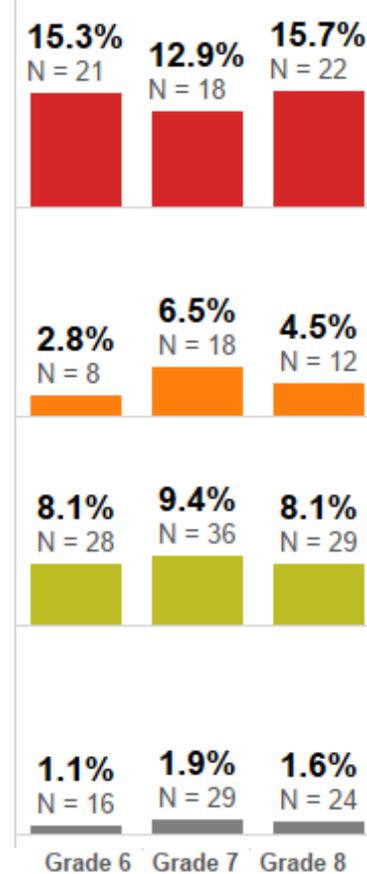



Suspension rates for African American Students with IEPs decreased in grade 6 by 1.4% and decreased in grade 7 by 4.2% from 2024-25 to 2025-26.

They decreased in grade 8 by 1.3%.

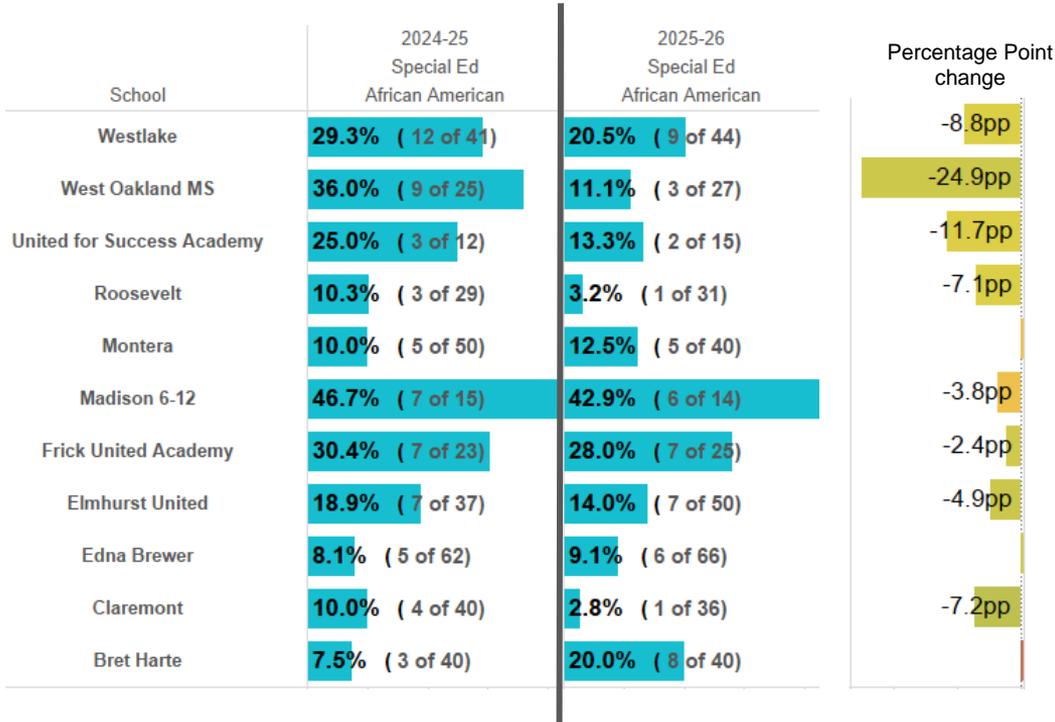


Suspension rates for African American Students with IEPs increased by 3.8 percentage points in grade 9.

They decreased slightly in grades 10-12.

At this time last year (2024-25) the average suspension rate grades 6 to 8 was **9.2%**. This average has decreased so far this year at **7.9%**.

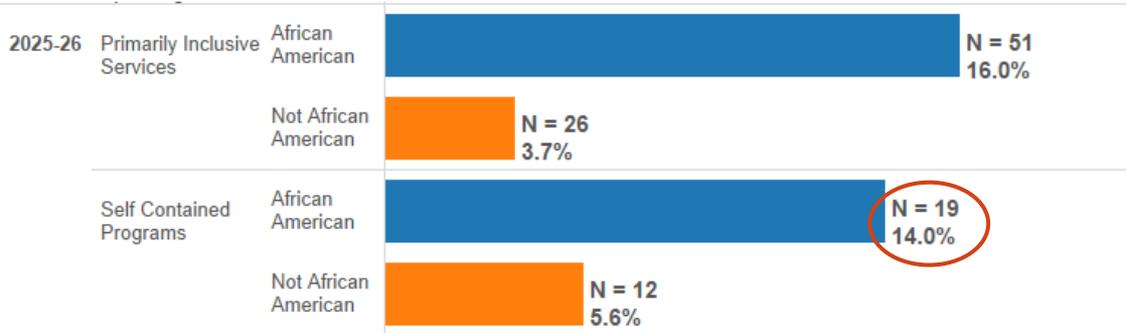


What **program types** were associated with the highest rates of suspensions for African American Students with Disabilities?

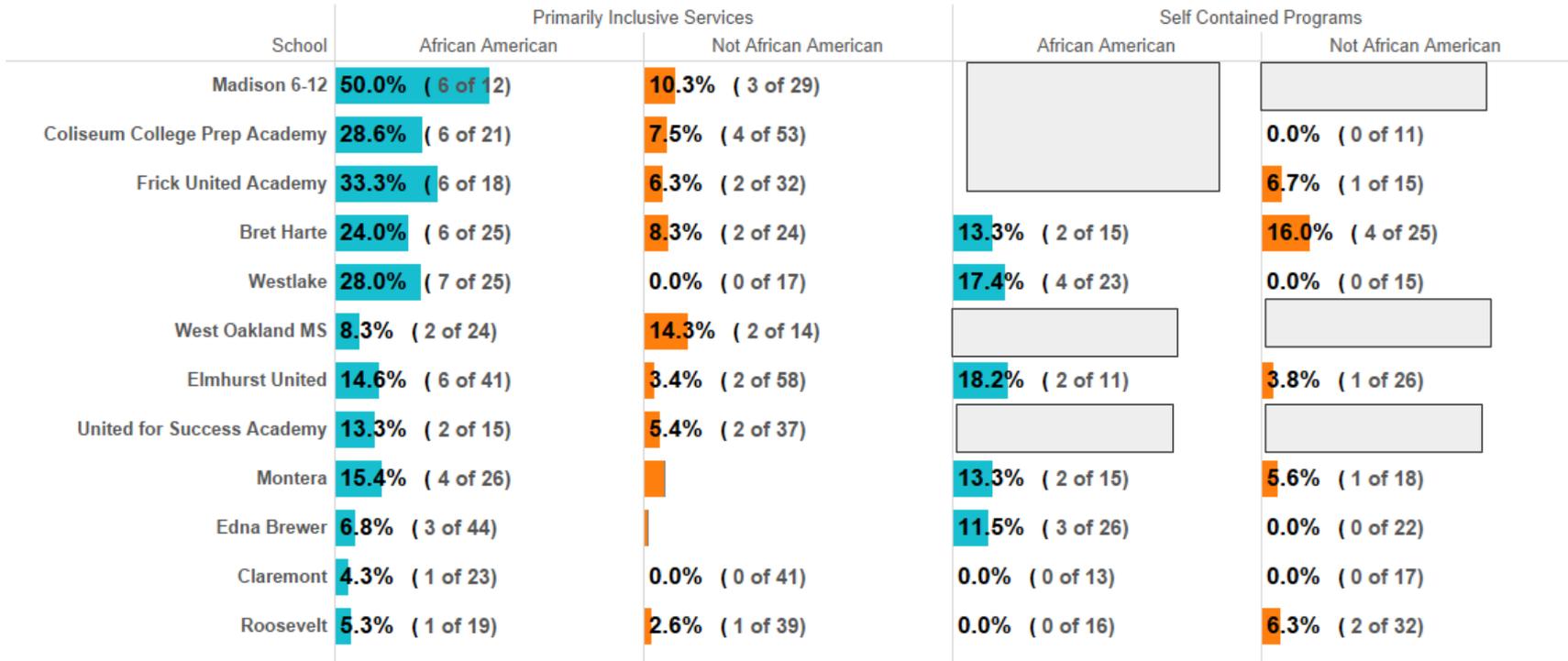


The year to date suspension rates for 6th to 8th grade African American students in Self-Contained Programs decreased by about **3 percentage points** from 2024-25 to 2025-26.

What does the suspension of African American Special Education students look like across school and broken down by program type?

Suspension rates by program type at different schools

Results suppressed when N<10. Schools with grey boxes do not serve a significant number of students in that program type.



The top suspension rates for African American students in Self-Contained settings so far this year is at **Madison Park, CCPA, and Frick** each suspending at a rate above the district average for African American students with disabilities (XX%).

The top suspension rates for African American students receiving Primarily Inclusive services were at **Elmhurst, Westlake, and Montera**.

Please note: there are many schools who are not included in this chart due to having too few students in these subgroups.

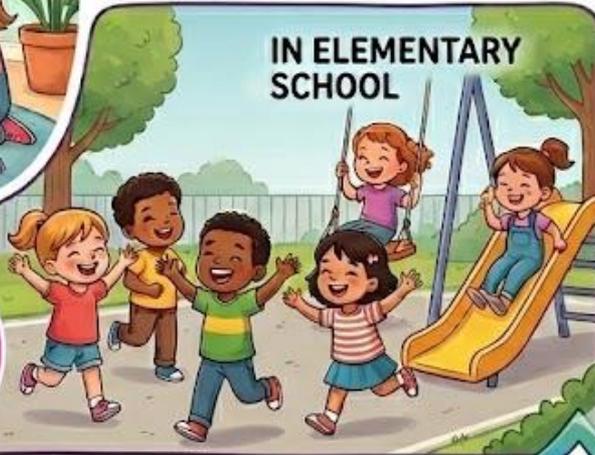



Students receiving BCBA support had higher overall suspension rates overall.

14.5% of students referred for BCBA support were suspended, while only 2.5% of students without a BCBA referral were suspended.

8.4% of students were suspended after receiving BCBA support. This means most students receiving services were not suspended afterward.



What types of activities are our BCBA's supporting?

Does BCBA reduce suspension risk compared to similar students?

- Across race, disability, and grade groups, students receiving BCBA services had higher suspension rates than comparable peers without BCBA.

These are overall suspension rates, not accounting for when BCBA services were provided.


A regression analysis controlling for race, disability, IEP status, and grade level shows:

- Students receiving BCBA support remain about **10 percentage points more likely** to be suspended than comparable peers, though there is a **significant reduction** in suspension following BCBA involvement.

Not Black	9.7%	1.4%

Are our BCBA services increasing time learning? Are they reducing suspension?

Impact of BCBA Support on Suspension Rates



*Each icon represents 1% of students (Total 100 students per group). Red/Orange icons represent suspensions.

Summary of Our Data

Students with IEPs with the highest rates of suspension are being referred to receive BCBA support.

Students who receive BCBA support have a reduction in suspension to 8% of students being suspended after supports start.

This suggests that these supports are being applied appropriately and are producing desired results, though suspension remains an ongoing area to improve.

Middle School Network Key Initiatives

1) In Principal Professional Learning:

Principals engage in data analysis and set goals related to school culture and climate.

They showcase best practices, present initiatives that are having a positive impact, and discuss successful Tier 2 and Tier 3 strategies.

A presenting principal shares an issue or question, and all principals engage in collaborative problem solving to resolve the issue or answer the question.

Middle School Network Key Initiatives

2) Middle School Behavior Analysts (BCBA):

BCBAs facilitated professional development in *Principal Professional Learning* to discuss Tier 1, 2 & 3 strategies, including how to positively implement Check In and Check Outs (CICO), Behavior Support Plans, and Behavior Intervention Plans.

3) Middle School Network Team:

attends school site culture/climate team meetings, sets goals with each site, monitors site suspension data, discusses ongoing data, shares effective strategies in Principal Professional Learning, and celebrates positive outcomes.

Middle School Network Key Initiatives

4) School Site Administrative and Culture Climate teams:

engage in data analysis, unpack root causes, set goals, create plans, and monitor progress on outcomes.

5) Administrative teams:

Some Details about the Central Reductions

About $\frac{1}{3}$ of the reductions are to administrative and confidential positions.

This list combines positions for which people have accepted early retirement with other position reductions.

Some reductions, such as those to newcomer support positions, are based on the number of enrolled students for which positions were intended.

As discussed in scenarios for the budget, the school networks are being reduced and combined. There will only be one elementary network instead of three. Based on the eliminations, there will also be other changes to how schools are centrally supported.

Some Special Education Highlights

The proposal to reduce Special Education spending is still under review. Leaders from Special Education, Fiscal Services, and our Labor Partners will be collaborating to present a joint plan.

The stated goal is to ensure full compliance with federal and state special education law while maintaining all mandated services for students with disabilities.

Leaders are analyzing what could be driving up costs across types of placements, related services, transportation, and contracts with third parties.
