NOTICE OF PUBLIC HEARING

PROPOSING THE "OAKLAND UNIFIED SCHOOL DISTRICT TEACHER RETENTION AND EDUCATIONAL PROGRAMS REPLACEMENT ACT," OR MEASURE "[]" (ALPHA DESIGNATION TO BE ASSIGNED BY THE ALAMEDA COUNTY REGISTRAR OF VOTERS), A REPLACEMENT PARCEL TAX FOR EDUCATIONAL PROGRAMS IN THE OAKLAND UNIFIED SCHOOL DISTRICT, FOR SUBMISSION TO VOTERS IN THE GENERAL ELECTION, NOVEMBER 3, 2026.

NOTICE IS HEREBY GIVEN that on Tuesday, August 4, 2026, at 10:00 A.M., or as soon thereafter as the matter may be heard, in person and virtually (Live Streaming via Internet and KDOL-TV Channel 27 (Comcast) and Channel 99 (AT&T)), the Governing Board of the Oakland Unified School District, at a Special Meeting, in the Committee Room, KDOL-TV Studio, 8-237, Met West High School Entrance, 314 East 10th Street, Oakland, CA 94606, will hold a Public Hearing on the proposed "Oakland Unified School District Teacher Retention and Educational Programs Replacement Act," or Measure "[]" (alpha designation to be assigned by the Alameda County Registrar of Voters), a proposed \$195 per parcel special Parcel Tax Measure, with annual cost-of-living adjustments, which shall be levied for 14 years commencing July 1, 2029, upon expiration of the District's existing Measure G1 Parcel Tax, for submission to District voters at the General Election to be held November 3, 2026.

The proposal is a request to District voters for approval (two-thirds voter approval required) to levy a replacement qualified special tax of \$195 per parcel annually for 14 years, with annual cost-of-living adjustments, on all taxable, non-exempt real property within the District, in order to support specified educational programs in the District. The proposed replacement parcel tax would become effective July 1, 2029, upon the expiration of the District's existing Measure G1 Parcel Tax, ensuring no gap in District educational program funding. Exemptions from the proposed replacement parcel tax will be granted, upon application, for parcels owned and occupied as a principal residence by persons who are 65 years of age or older, for parcels owned by persons receiving Supplemental Security Income for a disability regardless of age, and for parcels owned by persons receiving Social Security Disability Insurance benefits, regardless of age, and who are low-income, as specified in the measure. The Governing Board will consider taking final action on the proposal at the meeting. Members of the public are invited to attend and make oral and/or written presentations at the hearing. The proposed replacement parcel tax would fund specific educational purposes, including teacher retention and improving educational programs at the middle school level.
